

51. Briefly describe the vegetation and habitat conditions on the property. [help]
This is generally characterized as intertidal mudflats, exhibiting shallow gradients. Substrate is sandy with some muddy sand. Native eelgrass (<i>Zostera marina</i>) is present in areas with appropriate habitat. There is also other macroalgae and the non-native eelgrass (<i>Zostera japonica</i>) present in the clam culture areas.
According to data from the US Department of Agriculture, this area is in a high intertidal location where diatoms and other vegetation may also occur. Manila clams are typically grown at higher tidal elevations. This area was mapped in 2020 imagery as having native eelgrass present; however, this map may also reflect other vegetation with similar image spectrum characteristics (Lewis, personal communication, 2021). The 2009 data suggests eelgrass may be or may have been absent at this site. According to the grower (Kemmer, personal communication, 2021), this area does have eelgrass and there does not appear to be limitations to eelgrass growth. Overall, native eelgrass is believed to be either stable or expanding in the area that is part of Project 1.

This parcel has been previously permitted for shellfish aquaculture under Corps Permit Number NWS-2012-1104. There are no changes from the previously approved shellfish activities.

No permanent construction is proposed. Project 1 is located at the north end of Willapa Bay near Leadbetter Point State Park (refer to JARPA Drawings). The farm area is a Manila clam bed with a few oysters scattered in the area. Harvest methods are through hand-picking and no mechanical harvest equipment is used in this location. Additional details on culture methods are provided below.

MANILA CLAM CULTURE METHODS

The information below describes planting, frosting (graveling), and harvest culture methods for Manila clams.

Planting culture methods

Hatchery-grown clams are seeded by hand directly onto the beach substrate. Natural spawning and setting of clams will also occur. After seeding, predator exclusion nets may be used to cover the clam bed, with edges

anchored using rebar or buried in the substrate. Nets would remain in place until harvest, which generally takes 2-3 years.

Frosting (Graveling) methods

Prior to planting, clam beds are prepared by applying a thin layer of washed gravel mixed with shell fragments directly to the substrate (i.e., frosting). This activity occurs every 2 years or so, when the tide is high enough to float a barge carrying the frosting material. Material will be distributed evenly across the bed from a barge or skiff to a depth of less than 0.5 inches when the tide is high enough to float a barge. Several thin layers of material may be placed over a period of days. To place a single 0.5-inch layer requires about 70 cubic yards (CY) of washed gravel or shell per acre. An individual site would not be frosted more frequently than once every 2 years.

Harvest methods (hand harvest)

Hand harvesters dig clams or oysters during low tides using a clam rake every 2-3 years. Shovels or other hand operated tools may also be used. Market-size clams and oysters are selectively harvested, placed in buckets, bagged, tagged, and removed. Undersized shellfish are returned to beds for future harvests. Since a given clam bed may contain multiple year classes of clams and oysters, it may be harvested on a regular schedule to harvest individual year classes. Hand-picking disturbs the top 1 to 2 inches of sediment, and these effects persist for approximately 1 tidal cycle (Suhrbier et al. 2017). Dredging effects are not relevant for this area.







On behalf James J. Kemmer and Andrea Randall of Station House Oyster Company, we are submitting a permit application for Water Quality Certification (WQC) under Section 401 of the Clean Water Act for the Station House Oyster Company Parcel #79005003147 (OB-E147), which is an existing shellfish farm in Willapa Bay, Pacific County, Washington.

This application is for an existing shellfish farm that has been continuously permitted and operating for nearly ten years (previous NWS-2012-1104). The current permitting effort will use the same number. The project parcel comprises 5.0 acres of intertidal land, all of which is actively used for culture. The species under cultivation is Manila clam (*Venerupis philippinarum*). Clams are ground-cultured without any structures. Pacific oysters (*Crassostrea gigas*) naturally occur at low density in the project area and are harvested by hand. Both of these species were identified as cultured in past Nationwide Permit 48 efforts. Station House Oyster Company is seeking approval to continue permitted activities only. There are no changes to the planned operations or areas from the past permit for this site.

Station House Oyster Company submitted a Pre-Filing Meeting Application to the Washington State Department of Ecology on December 2, 2020.
