

## Public Notice of Request for Coastal Zone Management Act Federal Consistency

Public Notice Date: August 23, 2023

Comment Period Ends: September 14, 2023

The Department of Ecology (Ecology) has received the following request for a Coastal Zone Management Act (CZMA) federal consistency decision. Ecology is evaluating this proposal for consistency with the <u>enforceable policies</u> of Washington's Coastal Zone Management Program (CZMP). The federal CZMA authorizes states with approved CZMPs to review federal actions, which include federal agency activities and the issuance of federal permits and licenses. After this review is complete, Ecology will issue a decision on whether the proposal is consistent with the CZMP's enforceable policies; Ecology will either concur or object that the activity is consistent to the maximum extent practicable.

Under Washington's CZMP, federal actions that may affect any land use, water use, or natural resources in the coastal zone must be consistent with the enforceable policies found within the following state authorities:

- Washington Clean Air Act
- Washington State Water Pollution Control Act
- State Shoreline Management Act
- Ocean Resources Management Act
- Marine Spatial Plan for Washington's Pacific Coast

Ecology is seeking comments from the public, state and local agencies, tribes, and other interested parties regarding the proposal as part of the state's federal consistency review. Proposal or Project Name: Meador and Picquelle Pier

**Applicant:** James Meador and Susan Picquelle

**Location:** 16902 Scandia Lane Northwest, Poulsbo, Kitsap County.

**Description:** Rebuild and reconfigure an existing pier in Liberty Bay, work to include:

- Remove 100% of the existing 115-foot long by 4-foot, 5-inch wide (518-square feet) solid decking pier.
- Remove (11) 10-inch creosote piles, 2 of which are encased in concrete.
- Install proposed 57-foot, 5-inch long by 4-foot wide (230 square feet) fully grated aluminum pier.
- Install proposed 30-foot long by 8-foot-wide float with 50% functional grating (60% open area).
- Install 36-foot long by 3-foot wide fully grated aluminum ramp.
- Install (8) 10-inch galvanized steel support piles.

Additional work: Cover existing concrete steps from bulks to beach access with a 20-foot long by 3-foot-wide grated ramp. The applicant proposes to remove creosote and pay a conservation fee for the required Endangered Species Act (ESA) mitigation. The applicant has confirmed all General Construction Measures and Project Design Criteria have been met. The purpose of the project is to upgrade the dock and improve recreational activities.

**Proposal or Project Name:** Shi Pier Extension and Bulkhead Repair

**Applicant:** Yuhui Shi

**Location:** 6031 77th Avenue Southeast, Mercer Island, King County.

**Description:** Drive (4) 8" steel piles, install a 24' x 5'-10" extension with grated decking material, repair 108' of the bulkhead including the cove, relocate an existing PWC lift, install a new PWC lift,

and replace the moorage cover with CrystaLite translucent roofing.

Proposal or Project Name: Hung Pier Lifts

**Applicant:** Claudia Hung

**Location:** 68 Cascade Key, Bellevue, King County.

**Description:** Install a 15-foot, 9-inch long by 12-foot wide, 2-inch long (194- square feet) boatlift.

Install a 9-foot, 10-inch long by 9-foot, 10-inch wide(97-square feet) platform lift.

Proposal or Project Name: Nash Pier

**Applicant:** Michael Nash

Location: 9425 Lake Washington Boulevard Northeast, Bellevue, King County.

**Description:** Enlarge an existing 78 square foot grated pier finger by removing the decking and reframing with a 160 square foot grated pier finger via manual labor. A barge mounted crane will

remove (1) 31 square foot freestanding boatlift with a catwalk and place (2) 31 square foot boatlifts with grated catwalks. A planting plan consistent with the RAP programmatic is proposed.
