

### Public Notice of Request for Coastal Zone Management Act Federal Consistency

Public Notice Date: December 18, 2023 Comment Period Ends: January 10, 2024

The Department of Ecology (Ecology) has received the following request for a Coastal Zone Management Act (CZMA) federal consistency decision. Ecology is evaluating this proposal for consistency with the <u>enforceable policies</u> of Washington's Coastal Zone Management Program (CZMP). The federal CZMA authorizes states with approved CZMPs to review federal actions, which include federal agency activities and the issuance of federal permits and licenses. After this review is complete, Ecology will issue a decision on whether the proposal is consistent with the CZMP's enforceable policies; Ecology will either concur or object that the activity is consistent to the maximum extent practicable.

Under Washington's CZMP, federal actions that may affect any land use, water use, or natural resources in the coastal zone must be consistent with the enforceable policies found within the following state authorities:

- Washington Clean Air Act
- Washington State Water Pollution Control Act
- State Shoreline Management Act
- Ocean Resources Management Act
- Marine Spatial Plan for Washington's Pacific Coast

Ecology is seeking comments from the public, state and local agencies, tribes, and other interested parties regarding the proposal as part of the state's federal consistency review. **Description:** The applicant proposes to install a new 338 square feet (SF) translucent canopy on an existing, previously permitted, residential boatlift, waterward of the Ordinary High-Water Mark.

**Proposal or Project Name:** Sandy Hook Yacht Club Estates Maintenance Dredging **Applicant:** Sandy Hook yacht Club Estates Inc.

Location: 8224 Sandy Hook Drive, Clinton, Island County.

**Description:** Maintenance dredging of the harbor and navigating channel associated with the marina. Total dredged material from both phases of the project will not exceed 29,141 cubic yards. Excavation will be restoring an elevation to -3 feet (tidal datum) within the navigation channel and -4 feet (tidal datum) within the inner harbor. The new proposed project is to perform maintenance dredging to restore navigational safety for the existing navigational channel and to restore necessary water depth within the inner harbor and existing docking areas associated with the Sandy Hook Yacht Club marina.

Proposal or Project Name: Hocking Joint-Use Dock Expansion

Applicant: Bert Edward Jr. Hocking

Location: 388 Rocky Bay Road, San Juan Island, San Juan County.

**Description:** Remove an existing 9' by 44' partially grated timber deck float and install a new 8'x60' fully grated mooring float. The existing 2.5' by 11' partially grated timber ramp landing float would also be removed and replaced with a 6' by 10' fully grated landing float. The proposed replacement structures would be 116.5 SF more than the existing structures and would extend the float footprint length.

Proposal or Project Name: High Cedars Non-Federal Levee Repair

Applicant: US ACOE Walla Walla

Location: Puyallup River in Pierce County.

**Description:** Repair the damaged High Cedars Levee to its pre-flood event, as-designed level of protection. All repair work will occur within the existing levee prism with no riverward encroachment.
