



**Public Notice of Request for Clean Water Act  
Section 401 Water Quality Certification**

The Department of Ecology (Ecology) has received the following request for Clean Water Act (CWA) Section 401 Water Quality Certification (WQC). Pursuant to Section 401 of the CWA, applicants for a federal license or permit for activities which may discharge to waters of the United States must seek WQC from the state with jurisdiction.

Under Section 401 of the CWA, federal agencies cannot issue a license or permit before Ecology makes a decision on a WQC request or waives the right to review. Any conditions that are included in the WQC then become conditions of the federal permit or license. For information regarding Ecology's CWA Section 401 WQC, please visit Ecology's [webpage](#).

Ecology is seeking comments from the public, state and local agencies, tribes, and other interested parties regarding the proposed activity.

**1. Aquatics ID: 143486**

**Project Name:** Leisure Pine Lake Residential Development

**Applicant:** Leisure Pine Lake LLC

**Location:** Sammamish, King County

**Description:** Place fill in two Category III palustrine forested depressional wetlands to create a residential development.

**2. Aquatics ID: 144104**

**Project Name:** Coney Island Park Pier/Dock and Shoreline Stabilization

**Applicant:** City of Medical Lake

**Location:** 200 W Lake Street, Medical Lake, Spokane County

**Description:** We propose to restore the shoreline and construct a pier and floating fishing dock at Coney Island Park. The park currently has a shoreline stabilization system consisting of boulders and gravel that has been in place for at least 20 years. We propose to remove the existing boulders, grade a 7-foot swath of shoreline, install geofabric, replace the boulders, fill the landward side with quarry basalt, and then cover the basalt with native soil. The proposed dock is 700 square feet. This includes a 20' x 25' fixed pier, a 20' x 5' floating walkway, and a 20' x 5' fishing dock. The fixed pier will have 12, 10-inch pylons. The floating dock will have an additional 2, 10-inch pylons.

**3. Aquatics ID: 143316**

**Project Name:** Ash Grove Cement Company Maintenance Dredge and Shoreline Material Recovery

**Applicant:** Ash Grove Cement Company

**Location:** 3801 East Marginal Way South, Seattle, King County

**Description:** Proposed maintenance dredging to provide adequate depths for safe access to the berth and barge operation. Maintenance dredging will occur in two areas: the berth area and along the slope, landward of the conveyor. Maintenance dredging at the berth area will include removing up to 700 cubic yards (cy) of sediment and accumulated aggregate material within an approximately 3,500-square-foot area. Maintenance dredging along the slope area will include removing up to 300 cy of accumulated aggregate material within an approximately 3,000-square-foot area.

**4. Aquatics ID: 134599**

**Project Name:** Duwamish Yacht Club Maintenance Dredge

**Applicant:** Duwamish Yacht Club

**Location:** 1801 South 93rd St, Seattle, King County

**Description:** Maintenance dredging at the yacht club using a barge mounted clamshell and/or specially equipped excavator to depths of -8 to -9 ft mean lower low water (MLLW) total dredge depth. An estimated 40,600 cubic yards of material is expected to be dredged. Placement of a 1-foot thick sand cover over the southwest area of the project.

**5. Aquatics ID: 140753**

**Project Name:** Bothell Senior Living

**Applicant:** SP Martha Real Company LLC

**Location:** 2501 Maltby Road, Bothell, Snohomish County

**Description:** Proposal for a phased development of 200,800 sf combined independent living, assisted living, and memory care facility with parking and an access road. The building will be located in the central upland portion of the Site, but will encroach into Wetlands A, D, X, and Stream 2. All of Wetland X will be filled as part of the development. The calculated buffer areas will also be encroached upon for Wetland A, and Streams 1 and 2. The result is a total area of wetland and stream fill of 0.31 acres (13,560 sf) and a total area of buffer impact of 4.06 acres (177,135 sf). In addition, an associated trail network of 990 LF will be constructed in the northwestern portion of

the site, meandering through areas of 0.80 acres (34,929 sf) of newly constructed wetlands proposed for mitigation.
