Dear Ken Wiegardt:

On June 26, 2020, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the proposed project to continue operation of 28.5 acres of on bottom Manila clam culture. Manila clams are produced through natural recruitment. Harvest occurs by hand at low tide. Harvest will occur every 2 to 4 years depending on clam density and growth. Clam beds are maintained by a light frosting of gravel that is washed twice by the supplier. Frosting will occur every 3 to 5 years.

The project site is located on tidelands within Willapa Bay on parcel numbers 79004000108, 7900400072, and 79004001103, near Ocean Park, Pacific County, Washington; Section 2 and 35, Township 11N and 12N, Range 11W; WRIA 24, Willapa Watershed.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Wiegardt and Sons, Inc. determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
