Dear Ken Wiegardt:

On March 22, 2021 the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the proposed project to continue operation of 100 acres of on bottom oyster culture and 71 acres of fallow ground. On bottom oysters are produced through hatchery-produced seed. Hatchery produced seed is planted after the mature oysters have been removed. Oysters are harvested every 3 to 5 years depending on oyster density and growth. Thirty (30) acres are dredge harvested each year. Hand harvest at low tide also occurs. This project is not proposing any harrowing, frosting, or graveling.

The project site is located on tidelands within Willapa Bay on parcel numbers 79003000128, 79003000144, and 79003000139, near Ocean Park, Pacific County, Washington; Section 18, 19, and 30, Township 12N, Range 10W; WRIA 24, Willapa Watershed.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Wiegardt and Sons Inc.'s determination that the proposed work is consistent with Washington's CZMP.

## YOUR RIGHT TO APPEAL

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
