On January 11, 2021, Chuckanut Shellfish, Inc., submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Chuckanut Shellfish Wiggin Lease Farm located in the tidelands of Samish Bay, near Bow, Skagit County, Washington.

On January 11, 2021, Chuckanut Shellfish, Inc. submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Chuckanut Shellfish -Wiggin Lease Farm Samish Bay, near Bow, Skagit County, Washington. The US Army Corps of Engineers and Department of Ecology (Ecology) issued a joint public notice for the project on March 2, 2021.

Chuckanut Shellfish, Inc. proposes to continue operating the Wiggin Lease commercial shellfish farm on tidelands on parcel #P61609 in Samish Bay. The project area is 3.11 acres, of which 1.50 acres of is actively cultivated. On the actively cultivated area 1.09 acres is currently cultivated with Manila clams (Venerupis philippinarum). Manila clams will be cultivated between the +2.0 foot (ft) and +5.0 ft Mean Lower Low Water (MLLW) tidal elevations. Manila clams are cultivated in varying length rows under 48-inch wide rigid plastic mesh predator control nets. Each net is typically 150-ft. long. The net rows are separated by aisles about 1.5 ft. wide. Predator exclusion nets are installed with a tractor implement that creates a trench to sidecast material that is then backfilled to bury the edges of the net. The clams are harvested at low tide with a modified tulip bulb harvesting machine which separates the clams from the sand. Over the duration of the permit authorization, some, or all the 1.5-acres of actively cultivated area may be converted to geoduck clams (Panopea generosa) or Pacific oysters (Crassostrea gigas). Pacific ovsters will be suspended in plastic mesh bags or cages or on-bottom with harvest by hand. Geoduck will be cultivated using individual plastic mesh tubes without cover nets. This involves installing plastic mesh geoduck nursery tubes by pulling a core of sand out with a tool similar to a razor clam gun, sliding the net over the core and placing it back into the hole. Geoduck will be harvested using a hand-held water jet to liquefy the substrate so the geoduck clams can be removed by hand. Access to the site is by a 30-ft. vessel which pushes or tows a non-motorized scow. Eelgrass is present throughout the project area in areas that will not be cultivated.

The Wiggin Lease Farm is located on tidelands located on parcel #P61609, Township 36 N; Range 3 E; Section 28, in Samish Bay near Bow, Skagit County, Washington.

With this Order, Ecology is granting Chuckanut Shellfish, Inc.'s request for a Section 401 Water Quality Certification for the Chuckanut Shellfish - Wiggin Lease Farm, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on January 11, 2021, and the following supporting documentation:

1. E-mail to Ecology dated January 19, 2021, regarding Chuckanut Shellfish, Inc.'s water quality monitoring plan for the Wiggin Lease Farm.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project Chuckanut Shellfish, Inc. must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Chuckanut Shellfish, Inc. to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Condition:

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters <u>is prohibited¹</u>. If such work, conditions, or discharges occur, immediately notify² Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division³ at 1-800-258-5990, for actual spills to water only. This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Chuckanut Shellfish, Inc., Chuckanut Shellfish - Wiggin Lease Farm project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues an individual Department of the Army (DA) permit for this project. Order No. **19879** will remain

valid for the duration of the associated DA permit. Chuckanut Shellfish, Inc. should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within 30 days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
