Dear Kyle Lentz:

This Coastal Zone Consistency (CZM) Decision Letter corrects errors in the project description and location and supersedes the prior CZM Decision Letter sent out on April 8, 2021.

On December 14, 2020, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is to continue to commercially cultivate up to 3.83-acres of geoduck clams and 0.88-acres manila clams in an 8-acre project area (4.71-acre cultivation area) within the intertidal zone at the western portion of Eld Inlet, South Puget Sound, Thurston County, Washington.

The project site is located on tidelands between the +4.0-feet and -4.5 feet Mean Lower Low Water (MLLW) tidal elevations within the western portion of Eld Inlet, on parcel numbers: 12917130100, 3602001100, 12917130101, 12917130200, 12917130302, 12917130300, 93020500000, and 92051601000; adjacent to 7342 Young Road NW, near Olympia, Thurston County, Washington; Section 17, Township 19 North, Range 2 West; WRIA 14, Kennedy-Goldsborough Watershed

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Chelsea Farms determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:


- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
