On March 1, 2021, Pacific Shellfish Grays Harbor LLC submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Grass Creek DNR Lease, Grays Harbor County, Washington. The Department of Ecology (Ecology) issued a public notice for the project on March 18, 2021.

This project proposes to continue growing Pacific Oysters (Crassostrea gigas) on 11.59 acres in one (1) way at this location, (1) Oysters are grown on the ground using standard industry practices. The seed oysters are dispersed by boat at high tide and are harvested at high tide by boat or at low tide into tubs which are pulled at high tide by boat. Bed Prep: Oysters are harvested or transplanted from the bed using harvest methods outlined below. No more than 1" of shell or gravel will be placed annually, as needed, if the substrate is enhanced for the purpose of oyster cultivation. Onsite inspections by farm management will be performed prior for any bed cleanup prior to planting. Planting: The oysters are planted via a boat or scow at high tide. Maintenance: Beds are harvowed periodically depending on the substrate conditions that are most often influenced by sediment deposition or burrowing shrimp densities. Harvest: Oysters are harvester). The crop cycle is 2-3 years depending on site specific conditions. Harvest will occur year-round.

The project site is located on tidelands within Grays Harbor Bay, on DNR Lease No. 20-013589 on parcel number C2000A13589, near Westport, Grays Harbor County, Washington; Section 3, Township 17 North, Range 11 West; WRIA 22, Grays Harbor Watershed.

With this Order, Ecology is granting Pacific Shellfish Grays Harbor LLC's request for a Section 401 Water Quality Certification for the Grass Creek DNR Lease project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on March 1, 2021 and the following supporting documentation:

Pacific Shellfish Grays Harbor LLC water quality monitoring plan, and Pacific Shellfish Grays Harbor LLC commitment to follow the 2019 Puget Sound Shellfish Growers Association Environmental Codes of Practice for Shellfish Aquaculture.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Pacific Shellfish Grays Harbor LLC must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Pacific Shellfish Grays Harbor LLC to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

## **Special Condition:**

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters <u>is prohibited<sup>1</sup></u>. If such work, conditions, or discharges occur, immediately notify<sup>2</sup> Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division<sup>3</sup> at 1-800-258-5990, for actual spills to water only. This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Pacific Shellfish Grays Harbor LLC, Grass Creek DNR Lease project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues an individual Department of the Army (DA) permit for this project. Order No. **19990** will remain valid for the duration of the associated DA permit. Pacific Shellfish Grays Harbor LLC should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

### YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within 30 days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
