On May 15, 2020, Heckes Clams Inc. submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Oyster Beds E-181 and E-184, Pacific County, Washington. The Department of Ecology (Ecology) issued a public notice for the project on May 19, 2020.

This project proposes to continue farming Pacific Oysters on two parcels in Willapa Bay. The maximum area that would be used for on bottom oyster cultivation at one time is 20 acres (10 acres on each oyster bed). Oysters may naturally set on the bed or may be seeded by hand or from a vessel using a sluicing technique. Shell may be spread for catching naturally recruiting larvae. Oysters may be transplanted during grow-out to fattening beds. Oyster beds may be harrowed during grow-out to move the oysters back to the sediment surface. Oysters are harvested by dredge basket at high tide when they reach market size, after 3 or 4 years.

The project site is located on tidelands within Willapa Bay, on parcel numbers 79005000184 and 79005000181, adjacent to 28107 Sandridge Road, Nahcotta, Pacific County, Washington; Section 35, Township 13 North, Range 11 West; WRIA 24, Willapa Watershed.

With this Order, Ecology is granting Heckes Clams Inc.'s request for a Section 401 Water Quality Certification for the Oyster Beds E-181 and E-184 project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on May 15, 2020, and the following supporting documentation:

 E-mail letter to Ecology dated May 5, 2021, regarding the project's compliance with the conservation measures associated with the "Programmatic Biological Opinions for Shellfish Activities in Washington State Inland Marine Waters" (U.S. Fish and Wildlife Service (USFWS) Reference Number 01EWFW00-2016-F-0121, National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502). This email also includes a description of Heckes Clams Inc. water quality monitoring plan, and Heckes Clams Inc. commitment to follow the 2019 Puget Sound Shellfish Growers Association Environmental Codes of Practice for Shellfish Aquaculture. Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Heckes Clams Inc. must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Heckes Clams Inc. to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

### **Special Condition:**

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters <u>is prohibited<sup>1</sup></u>. If such work, conditions, or discharges occur, immediately notify<sup>2</sup> Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division<sup>3</sup> at 1-800-258-5990, for actual spills to water only. This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Heckes Clams Inc., Oyster Beds E-181 and E-184 project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues an individual Department of the Army (DA) permit for this project. Order No. **20054** will remain valid for the duration of the associated DA permit. Heckes Clams Inc. should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

#### YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).
