Dear Kyle Lentz:

On January 6, 2021, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is to continue the cultivation of 0.79 acres of geoduck clams over a 2.78 project area. All farming activities occur on privately owned tidelands from +2.0 Mean Lower Low Water (MLLW) tidal elevation to -3.5 MLLW tidal elevation within the surveyed property boundaries.

This project is located on tidelands within Hammersley Inlet, on parcel numbers 320224600190 and 320224670010, adjacent to 901 SE Old Arcadia Road, near Shelton, Mason County, Washington; Section 22, Township 20 North, Range 3 West; WRIA 14, Kennedy-Goldsborough Watershed.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Chelsea Farms' determination that the proposed work is consistent with Washington's CZMP.

## YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
