RE: Federal Consistency Concurrence for USACE Repairs at Skagit River Diking Districts 3 and 12 along the Skagit River, in Skagit County, Washington

## Dear Laura Boerner:

On April 14, 2021, the Seattle Branch of the Army Corps of Engineers (USACE) sent the Department of Ecology (Ecology) a Consistency Determination (CD) for repairs to levee damage along the Skagit River in Burlington and Mount Vernon in Skagit County. Flooding damaged the levees in February, 2020, and the USACE conducted emergency repairs to the Diking District-12 levee. The proposed action is to restore the levees to their pre-flood level of protection.

The project triggers Washington's Coastal Zone Management Program's (CZMP) enforceable policies found in the state Shoreline Management Act, and the USACE opted to demonstrate compliance with those policies by analyzing the Cities of Burlington and Mount Vernon Shoreline Master Program. Additionally, Ecology sent a letter to the Corps on June 22, 2021, indicating that an individual Section 401 Water Quality Certification would not be needed for the project, which satisfies the requirement that the project be consistent with the state Water Pollution Control Act's enforceable policies. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with the USACE's determination that the proposed project is consistent to the maximum extent practicable with Washington's CZMP.

## YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2). To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form by mail or in person (addresses below). E-mail is not accepted.
- Comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
