RE: Coastal Zone Consistency for Corps Reference #NWS-2020-860, Aqua Dock Reconfigure Project, Mercer Island, King County, Washington

Dear Marty Lott:

On October 28, 2020, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. On April 13, 2021, Marty Lott and Ecology agreed to stay the CZM until July 28, 2021.

This decision is for replacement of an existing 1,117-square-foot pier with a reconfigured 1,287square-foot pier, including: removal of eight 8-inch-diameter wood piles and installation of new 43-square-foot double freestanding personal watercraft lifts with a 47-aquare-foot walkway, fully grated decking to 372 square feet of pier, 18 8-inch-diameter steel piles, nine 8-inch-diameter brace piles, and one 12-inch-diameter steel mooring pile. The project is located at 6855 W. Mercer Way, Mercer Island, Washington, in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Marty Lott's determination that the proposed work is consistent with Washington's CZMP.

## **YOUR RIGHT TO APPEAL**

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.
