RE: Coastal Zone Consistency for Corps Reference #NWS-2020-1172, Lea Hill Elementary School Replacement Project, Auburn, King County, Washington

Dear Jeff Grose:

On June 15, 2021, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This decision is for replacement of the Auburn School District No. 408 Lea Hill Elementary School, including: demolition and removal of an existing 30,600-square-foot building and; removal of an existing covered play area, septic system, and portable buildings; construction of a 73,000-square-foot building with 2,800 square feet of covered play area, parking lots to the north and south of the building, an exterior plaza/courtyard, hard and soft surface play zones, and a synthetic grass field; and installation of a stormwater system. The work will impact approximately 0.014 acre of wetland. The project is located at 30908 124th Avenue SE, Auburn, Washington, in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Auburn School District No. 408's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

• File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.

• Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
