RE: Coastal Zone Consistency for Corps Reference #NWS-2019-650-WRD, Kayak Point County Park Day Use Area Improvements, Stanwood, Snohomish County, Washington

Dear Carol Ohlfs:

On June 18, 2020, Snohomish County Parks, Recreation and Tourism submitted a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP). On December 2, 2020, Snohomish County Parks, Recreation and Tourism and Ecology agreed to stay the CZM until June 18, 2021. A second stay was agreed to on May 28, 2021, extending the review period until October 15, 2021. On September 20, 2021, a third stay was agreed to, extending the review period until February 7, 2022.

This determination is for improvements to existing park recreational opportunities while protecting the existing park area from anticipated sea level rise. These activities would be located at the Kayak Point County Park, 15711 Marine Drive, Port Susan, Puget Sound, in Stanwood, Snohomish County, Washington,

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Snohomish County Parks, Recreation and Tourism's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by

Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
