On May 19, 2022, the Port of Clarkston submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Port of Clarkston Berth Maintenance Dredging Project, Asotin County, Washington. The following required processing dates are referenced below:

- On April 19, 2022 the Port of Clarkston submitted a pre-filing meeting request.
- On June 16, 2022 Ecology issued a public notice for the project.
- On June 24, 2022 the Port of Clarkston submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.

The Port of Clarkston, in partnership with the U.S. Army Corps of Engineers and the Port of Lewiston, will perform maintenance dredging in the lower Snake River to restore the berthing areas to provide safe access to moorage by cruise boats and barges. Approximately 21,600 cubic yards of total dredged material will be removed from four berthing areas and disposed of in the Snake River near Bishop Bar (River Mile 118) to create shallow water resting/rearing habitat for juvenile salmonids. Dredging will be performed using mechanical equipment from the river bottom and loaded onto barges for transport to the disposal site.

The project site is located at the Port of Clarkston's berthing areas, 4th Street dock, grain terminal, recreation dock and cruise dock at 7th Street in Clarkston, WA, in the Snake River at Asotin County, Washington within Water Resource Inventory Area (WRIA) 35 Middle Snake.

With this Order, Ecology is granting the Port of Clarkston's request for a Section 401 Water Quality Certification for the Port of Clarkston Berth Maintenance Dredging Project provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on June 24, 2022.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, the Port of Clarkston, must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize the Port of Clarkston to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Port of Clarkston for the Port of Clarkston Berth Maintenance Dredging project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. Order No. 21300 will remain valid for the duration of the associated DA permit. The Port of Clarkson should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by RCW 43.21B and WAC 371-08. "Date of receipt" is defined in RCW 43.21b.001(2). More information is available at <https://eluhho.wa.gov/content/11>.

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
