Re: Coastal Zone Consistency for Activity Undertaken by a Federal Agency Naval Magazine Indian Island Ammunition Wharf Piling Replacement, Jefferson County, Washington

Dear Jarrett Schuster:

On September 1, 2022, the Department of the Navy (Navy) submitted a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP). At Ecology's request, the Navy submitted an addendum to the Consistency Determination on October 19, 2022. On October 25, 2022, Ecology requested a 15-day extension pursuant to 15 CFR 930.41(b). On October 27, 2022, Ecology and the Navy agreed to a second extension until November 18, 2022. The project is located on Ammunition Wharf at Naval Magazine Indian Island in Jefferson County, Washington.

The purpose of this project is to replace piles, perform maintenance, and conduct repair activities over a 7-year period on the Ammunition Wharf. This includes the removal and replacement of up to 120 structural concrete piles and fender piles. The number of replaced structural piles could include up to eight structural steel piles if inspections warrant steel pile replacement, and the remainder would be concrete piles. Maintenance activities include deck resurfacing and recoating various corroded metal components. Repair activities could be conducted on wetwell concrete spalling, the Ammunition Wharf pier and piles, and quay walls. Damaged or deteriorated components could be repaired or replaced, including brow floats, pile caps, safety ladders, cable straps, camel and camel connections, and lighting. The work would not change overwater coverage at the Ammunition Wharf. All pile driving would occur during the in-water work window (October 1 to January 16).

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Navy's determination that the proposed work is consistent with Washington's CZMP.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by RCW 43.21B and WAC 371-08. To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology, in paper form, by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
