Re: Coastal Zone Consistency for Boise Creek Restoration at Enumclaw Golf Course, Corps

Dear Eric Palmer:

On March 29, 2022, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. On August 25, 2022, the City of Enumclaw Public Works Department and Ecology agreed to stay the CZM, extending the review period until November 18, 2022, in order for the Applicant to comply with State Water Quality requirements. On November 15, 2022, a second stay was agreed to extend the review period to December 9, 2022.

This determination is for restoration of salmonid spawning habitat within a 530-linear-foot segment of Boise Creek and it will daylight a 900-linear-foot segment of Chappel Springs that is currently piped within the Enumclaw Golf Course. This involves creating a new channel for Boise Creek so it no longer bisects the golf course, and creating a new channel for Chappel Springs so it no longer is piped through the golf course. Construction of the new Boise Creek channel will cause 0.62 acres of wetland impacts that will be mitigated on-site by creating 0.93 acres and enhancing 0.65 acres of wetland. Daylighting of Chappel Springs will cause 0.03 acres of wetland impacts that will be mitigated on-site by creating 0.21 acres and enhancing 0.14 acres of wetland.

The project site is located at 45220-288th Avenue SE in Enumclaw, King County, Washington, Sections 29 and 30, Township 20 N., Range 7 E., within Water Resource Inventory Area (WRIA) 10–Puyallup/White.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with City of Enumclaw Public Works Department 's determination that the proposed work is consistent with Washington's CZMP.

Your right to appeal

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
