Re: Coastal Zone Management Federal Consistency Decision for North Marina Maintenance Dredging (Corps No. 202100528), Everett, Snohomish County, Washington

Dear Laura Gurley:

On February 18, 2022, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Then on August 9, 2022, the Port of Everett and Ecology agreed to stay the CZM until January 21, 2023, in order for the Applicant to complete the Section 401 Water Quality Certification process.

The project proposes maintenance dredging in the North Marina to facilitate continued use of the marina facilities and improve access to existing pier and dock structures. Barge-based mechanical dredging will be used. Dredged material will be transported to the disposal site by bottom dump barge. Approximately 103,675 cubic yards of material will be dredged over an area of 9.2 acres to a design dredge depth of -14 feet Mean Lower Low Water, plus 2 feet of over-dredge allowance. Suitable dredge material will be disposed of at the Port Gardner nondispersive disposal site.

The project site is located at 605 10th Street, Everett, Snohomish River, Snohomish County, Washington, Section 18, Township 29N., Range 5E., within Water Resource Inventory Area (WRIA) 7 Snohomish.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Port of Everett 's determination that the proposed work is consistent with Washington's CZMP. Corps No. 202100528, Aquatics ID No. 141385 January 20, 2023 Page 2 of 3

Your right to appeal

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
