On August 6, 2022, RS Construction Services, LLC submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the South Camano Drive Bulkhead Repair, Island County, Washington. The following required processing dates are referenced below:

- On June 3, 2022, the RS Construction Services, LLC submitted a pre-filing meeting request.
- On February 23, 2022, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under Nationwide Permit No. 13 and requires an individual Section 401.
- On August 12, 2022, Ecology issued a public notice for the project.

This project proposes to construct 195 linear feet (LF) of sheet piling bulkhead with backfill waterward of the HTL. The sheet piling bulkhead would be constructed up to 2 feet waterward of an existing damaged timber pile bulkhead. Up to 60 cubic yards of native fill material would be placed in the space between the existing and proposed bulkheads as backfill. If the required pile depth cannot be reached via vibratory hammer, up to 30 cubic yards would be excavated for trenching. All construction would take place from the beach with an excavator and small trucks, and all work would be conducted in the dry at low tide.

The project site is located at 3032 and 3034 South Camano Drive in Camano Island, Saratoga Passage, Island County, Washington, Section 9, Township 30 N., Range 3 E., within Water Resource Inventory Area (WRIA) 6 - Island.

With this Order, Ecology is granting RS Construction Services, LLC's request for a Section 401 Water Quality Certification for the South Camano Drive Bulkhead Repair project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on August 6, 2022, and the following supporting documentation:

Water Quality Monitoring Plan dated September 22, 2022.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, RS Construction Services, LLC must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize RS Construction Services, LLC to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the RS Construction Services, LLC for the South Camano Drive Bulkhead Repair project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. Order No. **21540** will remain valid for the duration of the associated DA permit. RS Construction Services, LLC should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by RCW 43.21B and WAC 371-08. "Date of receipt" is defined in RCW 43.21b.001(2). More information is available at https://eluho.wa.gov/content/11.

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
