Re: Termination of Water Quality Certification (WQC) Order No. 20065

Dear Kyle Lentz:

For the reasons stated below, the Department of Ecology (Ecology) hereby terminates Water Quality Certification Order No. 20065, pursuant to RCW 90.48.120.

Project Background

On May 18, 2021, Ecology issued a Section 401 WQC to Chelsea Farms for the 12 Chelsea Farms, Harstine Farm. This Section 401 WQC is for the expansion of an existing geoduck clam farm. The parcel to be added to the previously authorized Group 12 is owned by the Brandt's and is approximately 1.88 acres in size. It adjoins the Ison property which is a constituent of Group 12.

Ecology is terminating the Section 401 WQC Order No. 20065, because a new Section 401 WQC Order No. 21651 was issued on March 23, 2023. This new Section 401 WQC covers the existing aquaculture activities that were authorized under Order No. 20065, as well as the expanded activities recently proposed by the applicant in 2023. Therefore, the previous Section 401 WQC Order No. 20065 is redundant and is no longer necessary. The Army Corps of Engineers references the new Section 401 WQC Order No. 21651 in their Section 10 Letter of Permission that was modified most recently on April 17, 2023, to encompass the proposed expansion.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21b.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). “Filing” means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. “Notice of appeal” is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.

On June 23, 2020, Chelsea Farms submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the 12 Chelsea Farms, Harstine Farm, Mason County, Washington. The Department of Ecology (Ecology) issued a public notice for the project on October 22, 2020.

This project proposes to continue to commercially cultivate up to 0.75 acre of geoduck calms between +2-ft. MLLW and -4.5 ft. tidal elevations within a 1.88 acre project area on privately owned tidelands within Case Inlet of South Puget Sound.

Geoduck cultivation entails placing the geoduck seed within PVC anti-predator tubes (4-inch diameter by 10-inch length) at a density of one tube per square foot on the tidelands. Each tube will have a mesh cap secured with a rubber band resistant to UV light and salt water. The area will then be covered with netting composed of 40 ft. by 40 ft. squares (3-inch or smaller stretched mesh). The netting will be secured to the sand with 24-inch u-shaped rebar, spaced every 5 feet around the perimeter. Geoduck seed planting may occur at low tide in the “dry” or at high tide in the “wet.”

Between 6-12 months after planting, the caps and bands will be removed from the tubes; at 18-24 months, the tubes and netting will be removed from the site. The geoducks will be harvested at about 5-7 years using low-pressure water pumps with a “stinger/wand” with nozzle pressure to liquefy/loosen the sediment so that the geoducks can be removed by hand. Harvest will occur at low tide, or by divers at high tide.

No farming activities occur in the mid- or upper intertidal area, above +2.0 foot tidal elevation. All work activities are done by hand, access is typically by boat or by a privately owned boat ramp, no motorized machinery operates on the beach beyond the boat ramp, no refueling of engines or motors occurs on the beach, no equipment is stored on site, no rooted aquatic vegetation or benthic organisms are removed from the site, no fill or grading occurs at the site, no chemical or environmental contaminants are used, there is no redirection of beach seepage or seasonal upland runoffs, and farming activities create no substantial interference with normal public use of the surface waters.

The project site is located on tidelands within Case Inlet of South Puget Sound, on parcel numbers 220121400010 and, 220121400060, adjacent to 1300 E. Ballow Road on Harstine Island near Shelton, Mason County, Washington; Section 12, Township 20 North, Range 2 West; WRIA 14, Kennedy-Goldsborough Watershed.

With this Order, Ecology is granting Chelsea Farms' request for a Section 401 Water Quality Certification for the 12 Chelsea Farms, Harstine Farm project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on June 23, 2020, revised drawings received October 22, 2020, and the following supporting documentation:

- E-mail letter to Ecology dated March 11, 2021, regarding the project's compliance with the conservation measures associated with the "Programmatic Biological Opinions for Shellfish Activities in Washington State Inland Marine Waters" (U.S. Fish and Wildlife Service (USFWS) Reference Number 01EWF00-2016-F-0121, National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502). This email also includes a description of Chelsea Farms' water quality monitoring plan, and Chelsea Farms' commitment to follow the 2019 Puget Sound Shellfish Growers Association Environmental Codes of Practice for Shellfish Aquaculture.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Chelsea Farms must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Chelsea Farms to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Chelsea Farms from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Condition:

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited¹. If such work, conditions, or discharges occur, immediately notify² Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division³ at 1-800-258-5990, for actual spills to water only. This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Chelsea Farms, 12 Chelsea Farms, Harstine Farm project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues an individual Department of the Army (DA) permit for this project. Order No. 20065 will remain valid for the duration of the associated DA permit. Chelsea Farms should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within 30 days of the date of receipt of this Order:


