Re: Coastal Zone Management Federal Consistency Decision for Fisher Pier, Ramp, and Float Replacement (Corps No. NWS-2021-1141) Gig Harbor, Pierce County, Washington

Dear Marcie and Duncan Fisher:

On April 7, 2023, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the removal of an existing 123 foot pier, ramp, and float (PRF) consisting of 6x79 foot fully decked overwater pier supported by ten 15-inch diameter creosote treated wood piles, 4x35 fully grated ramp (spanning 29 feet), and 15x26 foot fully decked float supported by three 15-inch diameter creosoted treated wood piles, and a single pile in beach. Replacement consists of the installation of 123 foot PRF consisting of a 4x80 fully grated aluminum pier supported by four 10-inch diameter galvanized steel pier piles, re-use of 4x35 foot fully grated ramp (spanning 27 feet), and 8x8 grated landing float with 8x22 foot grated mooring float supported by five 10-inch diameter galvanized steel float piles with required float stops. These improvements would take place at 3410 East Bay Drive Northwest in Gig Harbor, Washington in Pierce County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with the Marcie and Duncan Fishers's determination that the proposed work is consistent with Washington's CZMP.

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
