Site Location	Cascade Natural Gas Anacortes Lateral Upgrade and Replacement Project located within several drainage ditches, Burlington and Sedro-Woolley, Skagit County, Washington.

Cascade Natural Gas Corporation (CNG) submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Cascade Natural Gas Anacortes Lateral Upgrade and Replacement Project, Skagit County, Washington. The following required processing dates are referenced below:

- On 1/25/2023, CNG submitted a pre-filing meeting request.
- On 3/27/2023, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 3/28/2023, CNG submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.
- On 4/5/2023 the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under Nationwide Permit No. NWP #12 and requires an individual Section 401.
- On 4/7/2023 Ecology notified the Corps that the project requires an individual Section 401 and the reasonable period of time for this project ends on 10/3/2023.
- On 6/16/2023, Ecology issued a public notice for the project.

This project proposes to replace 6.4 miles of 8-inch high pressure pipe with a 20-inch high pressure pipe. The existing 8-inch pipeline will be removed where required for construction of the new pipeline and abandoned in place and sealed where it is not removed.

The project site begins at the City of Sedro-Woolley at 48.516439 latitude and -122.238490 longitude and proceeding southwesterly, passing north of the City of Burlington, and ending

near the intersection of Josh Wilson Road and Pulver Road at approximately 48.486161 latitude and -122.351472 longitude in Skagit County, Washington, within Water Resource Inventory Area (WRIA) 3 Skagit River Basin.

With this WQC Order, Ecology is granting CNG's request for a Section 401 Water Quality Certification for the Cascade Natural Gas Anacortes Lateral Upgrade and Replacement Project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 3/27/2023, and the following supporting documentation:

- 1. Dewatering Plan revised, dated, and received on May 17, 2023.
- 2. Horizontal Direction Drilling Inadvertent Release Contingency Plan revised May 2023, received on May 17, 2023.
- 3. Water Quality Monitoring and Protection Plan revised and received June 26, 2023.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, CNG must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize CNG to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the CNG for the Cascade Natural Gas Anacortes Lateral Upgrade and Replacement Project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **22005** will remain valid for the duration of the associated DA permit. CNG should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21b.001(2).

To appeal, you must do all the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing options below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
