Re: Coastal Zone Management Federal Consistency Decision for Sullivan Drive Northwest (Corps No. NWS-2020-0483), Wollochet Bay, Gig Harbor, Washington

Dear Paul and Laurie Synder,

On June 2, 2023 the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Paul and Laurie Snyder's determination that the proposed work is consistent with Washington's CZMP.

The proposed work includes the replacement of an existing failing creosote treated timber bulkhead and stairway with a rock bulkhead in the same footprint. The replacement bulkhead will be 6-feet tall with 4.5-foot wide rocks at the base and 3-foot wide rocks at top. Work includes the excavation of 91 cubic yards of creosote treated timber and the placement of 91 cubic yards of rock along 109 linear feet of shoreline, with the placement of an additional 5 cubic yards of fill for beach nourishment. Project construction will use construction best management practices and temporary erosion and sediment control measures. This activity will occur in Wollochet Bay, at Gig Harbor, Pierce County, Washington.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
