Piling Repair and Dredging (Corps No. 202100456), Quillayute River Estuary and Pacific

Ocean, La Push, Clallam County, Washington

Dear Annie Foster:

On June 21, 2023, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with the Quileute Tribe's determination that the proposed work is consistent with Washington's CZMP.

The proposed work includes sediment removal dredging in the Quileute Marina to restore a design depth of -10-ft. plus 2 ft. of over depth to -12-ft. (MLLW), and the replacement of damaged piers and fingers and creosote-treated piling due to aging of the structures and winter storm damage in 2020. All pilings would be replaced with steel and driven using a vibratory hammer. All floats and piers would be replaced with grated decking instead of solid decking and remain within the same size as original except where width is increased for safety and ADA compliance. The Quileute Marina would be dredged by hydraulic dredge with placement on Quillayute Spit for beneficial beach nourishment. The removal of sunken debris would also occur.

This activity occurs within the Quillayute River Estuary and Pacific Ocean at the Quileute Marina within the Quileute Reservation, La Push, Clallam County, Washington.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
