Clark Regional Wastewater District submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Mt. Vista Trunk Upgrade, Clark County, Washington. The following required processing dates are listed below:

- On 9/30/2022, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under Nationwide Permit No. 58 and requires an individual Section 401.
- On 10/5/2022, the Clark Regional Wastewater District submitted a pre-filing meeting request.
- On 12/2/2022, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 12/8/2022, Ecology issued a public notice for the project.

This project proposes to replace roughy 1,140 linear feet of an existing 10-inch diameter sewer line with a 15-inch sewer line with the same alignment. Work would include excavation within the original alignment, removal of the existing pipe, and the replacement of bedding material and soils to bring the site back to the original grade. Removal and replacement of the existing trunk sewer pipe will cause temporary impacts within Wetland A and its buffer, which will be restored following project construction.

The project site is located at 14218 NE 35th Ave, Wetland A, Clark County, Washington, Section 24, Township 3 N., Range 1 E., within Water Resource Inventory Area (WRIA) 28 Salmon Washoughal.

With this WQC Order, Ecology is granting Clark Regional Wastewater District's request for a Section 401 Water Quality Certification for the Mt. Vista Trunk Upgrade project, provided that

the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 12/2/2022, and the following supporting documentation:

- 1. Wetland delineation submitted to Ecology on 8/3/2023, titled Critical Areas Report, dated April 28, 2023, prepared by Ecological Land Services.
- 2. Drawings submitted to Ecology on 8/3/2023, dated May 2023, prepared by Consor.
- 3. JARPA submitted to Ecology on 8/3/2023, dated July 31,2023, prepared by Clark County Regional Wastewater District.
- 4. Wetland mitigation plan submitted to Ecology on 8/8/2023, titled Mount Vista Trunk Upgrade Temporary Wetland Impact Restoration Memo, dated July 20, 2023, prepared by Clark County Public Works.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Clark Regional Wastewater District must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Clark Regional Wastewater District to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Clark Regional Wastewater District for the Mt. Vista Trunk Upgrade project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **22150** will remain valid for the duration of the associated DA permit. Clark Regional Wastewater District should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
