City of Snoqualmie submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Sandy Cove Park Temporary Bank Protection (Phase 1), King County, Washington. The following required processing dates are listed below:

- On 7/16/2021, the City of Snoqualmie submitted a pre-filing meeting request.
- On 6/5/2023, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 6/5/2023, the City of Snoqualmie submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.
- On 8/17/2023 the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under Nationwide Permit No. 13 and requires an individual Section 401.
- On 8/25/2023, Ecology issued a public notice for the project.

This project proposes to stabilize the eroding bank of Sandy Cove Park in Two Phases. Phase 1 will consist of using bank stabilization fill methods that include placing a layer of washed gravel, coir roll, sandbag ballast, and washed gravel filled supersacks along a section of bank approximately 400 feet in length. Phase 2 will be permitted at a later date.

The project site is located at 7970 Falls Avenue SE, Snoqualmie River, King County, Washington, Section 30, 31, and 32, Township 24 N., Range 8 E., within Water Resource Inventory Area (WRIA) 7, Snohomish.

With this WQC Order, Ecology is granting with conditions the City of Snoqualmie's request for a Section 401 Water Quality Certification for the Sandy Cove Park Temporary Bank Protection (Phase 1) project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 6/5/2023, and the following supporting documentation:

• 9/13/2023 Updated water quality monitoring and protection plan.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, the City of Snoqualmie must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize the City of Snoqualmie to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Condition:

1. The City of Snoqualmie must coordinate with Ecology, the Snoqualmie Indian Tribe, and other resource agencies on the design and construction of Sandy Cove Park Bank Protection Phase 2.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to the City of Snoqualmie for the Sandy Cove Park Temporary Bank Protection (Phase 1) project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **22305** will remain valid for the duration of the associated DA permit. The City of Snoqualmie should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it. Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
