WA State Parks and Recreation Commission submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Bowman Bay Pier Replacement project, Skagit County, Washington. The following required processing dates are listed below:

- On May 1, 2023, the WA State Parks and Recreation Commission submitted a pre-filing meeting request.
- On September 12, 2023, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On September 18, 2023, WA State Parks and Recreation Commission submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.
- On April 25, 2023, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under a Section 10 Letter of Permission (LOP) and requires an individual Section 401.
- On September 22, 2023, Ecology issued a public notice for the project.

This project proposes to replace the existing 6,932 square foot pier consisting of an abutment, creosote timber piles, floating timber dock and gangway with a new 6,372 square foot pier. A total of 156, 12-inch creosote piles encompassing 122 square feet of piles would be removed and 27, 18-inch steel piles encompassing 34 square feet would be placed below the Mean High-Water Mark.

The project site is located at 4399 Bowman Bay Road in City of Anacortes, Bowman Bay, Skagit County, Washington, Section 23, Township 34 N., Range 01E., within Water Resource Inventory Area (WRIA) 3 Lower Skagit – Samish.

With this WQC Order, Ecology is granting WA State Parks and Recreation Commission's request for a Section 401 Water Quality Certification for the Bowman Bay Pier Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on September 12, 2023.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, WA State Parks and Recreation Commission must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize WA State Parks and Recreation Commission to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the WA State Parks and Recreation Commission for the Bowman Bay Pier Replacement project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **22376** will remain valid for the duration of the associated DA permit. WA State Parks and Recreation Commission should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it. ## Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
