Re: Coastal Zone Management Federal Consistency Decision for Skinner Pier and Bulkhead Repair (Corps No. NWS-2022-0767), Lake Washington, King County, Washington

Dear Suzanne Skinner:

On June 21, 2023, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Suzanne Skinner's determination that the proposed work is consistent with Washington's CZMP.

The proposed work includes maintenance of an existing 561-square-foot pier, and removal of 116 linear feet of timber bulkhead and concrete stairs and replacement with 2-3 man rocks and stairs. Filter fabric is to be installed into the excavated area and backfilled with 2 to 4-inch cleaned crushed rock, and then enveloped with the filter fabric. Bulkhead work would be conducted from barge and land. Materials would be brought to the site by a barge, and a floating containment boom would be placed around the area before construction begins. This activity will occur in Lake Washington on Mercer Island.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). “Filing” means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. “Notice of appeal” is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
