Holt Homes submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Heartwood Subdivision project, Clark County, Washington. The following required processing dates are listed below:

- On March 15, 2023, Holt Homes submitted a pre-filing meeting request.
- On May 8, 2023, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On August 11, 2023 the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under Nationwide Permit No. 29 and requires an individual Section 401.
- On August 15, 2023, Ecology issued a public notice for the project.

This project proposes to discharge up to 25 cubic yards of fill material within 0.136 acres of Wetland F and Wetland G to construct a residential development. The proposed project will also involve indirectly impacting 0.009 acres of Wetland B and 0.095 acres of Wetland X due to insufficient buffer widths. The project will consist of lot development, interior roads, utilities, walking paths, stormwater facilities, and natural open space tracts. Compensatory mitigation will be provided by purchasing mitigation bank credits from Terrace Mitigation Bank and through other onsite measures.

The project site is located just southeast of 10913 NE 137th Ave, Vancouver, Clark County, Washington, Section 35, Township 3 N, Range 2 E, within Water Resource Inventory Area (WRIA) #28 Salmon Washougal.

With this WQC Order, Ecology is granting with conditions Holt Homes's request for a Section 401 Water Quality Certification for the Heartwood Subdivision project, provided that the

activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on May 8, 2023, and the following supporting documentation:

- 1) On May 8, 2023, Ecology received Holt Homes's Joint Aquatics Resources Permit Application (JARPA).
- 2) On May 15, 2023, Ecology received Holt Homes's notice for Determination of Non-Significance.
- 3) On November 2, 2023, Ecology received an email with Holt Homes's Final Bank Use Plan.
- 4) On November 2, 2023, Ecology received an email with the Final Critical Areas Report and Mitigation Plan.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Holt Homes must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Holt Homes to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Condition:

- 1. Holt Homes shall mitigate wetland impacts as described in Bank Use Plan prepared by Ecological Land Services, dated October 31, 2023 (received November 2, 2023), or as required by this Order.
 - Justification Alteration of water quality necessitates the use of mitigation as a method of controlling pollution. When adequate mitigation is provided, the impacts are not considered significant enough to water quality, at least in the long-term. The water quality standards, along with mitigation, protect wetlands as well as permitting some level of degradation where unavoidable or necessary.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.

- Holt Homes shall submit to Ecology documentation from the bank sponsor verifying the purchase of 0.233 wetland mitigation bank credits (credits) from the Terrace Mitigation Bank. This documentation must include the Ecology Order Number, Order issuance date, impact acreage, the amount of credits required by the Order, and date of credit purchase.
 - Justification This condition is necessary to ensure the compensatory mitigation was actually provided by the bank.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.
- 3. Unless otherwise authorized by this WQC Order, Holt Homes shall complete the purchase of credits before impacting wetlands. Otherwise, Ecology may require Holt Homes to provide additional compensation to account for additional temporal loss of wetland functions.
 - Justification Mitigation that is not emplaced concurrent with impacts will result in degradation of existing beneficial uses of the wetlands affected by the proposed action through temporal loss of functions.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to Holt Homes for the Heartwood Subdivision project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **22399** will remain valid for the duration of the associated DA permit. Holt Homes should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it. Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
