Re: Coastal Zone Management Federal Consistency Decision for Colony Creek MP 28.35 Pipeline Relocation (Corps No. NWS-2019-0825), Colony Creek, Bow, Skagit County, Washington

Dear Ed Smith:

On February 28, 2024, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Olympic Pipeline Company LLC's determination that the proposed work is consistent with Washington's CZMP.

The proposed work proposes to cut out and replace a portion of the existing petroleum products pipeline, install scour protection, bank protection, large woody material and engineered streambed material features in the channel to protect the pipeline, and stabilize the upstream and downstream banks. Mitigation will consist of the purchase of .01 credits from the Nookachamps wetland mitigation bank and site restoration will occur once the work is complete. This activity is located near Wood Road in Colony Creek, Skagit County, Washington.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). “Filing” means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. “Notice of appeal” is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
