Re: Coastal Zone Management Federal Consistency Decision for the Skokomish Valley Road

and Habitat Project (Corps No. NWS-2022-0664), Skokomish River, Skokomish, Mason

County, Washington

Dear Keith Underwood:

On October 5, 2023, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Mason Conservation District's determination that the proposed work is consistent with Washington's CZMP.

The proposed work includes installing 8 large, engineered log jams and 1,500 feet of side channel with 26 wood habitat structures to improve sediment transport and fish habitat. Additionally, the project will include building a 35 foot bridge over the mouth of the side channel, raising 3,500 feet of road to reduce over-topping during floods, and adding two flood culverts. This activity would occur in the Skokomish River, near Skokomish, Mason County, Washington.

Your right to appeal

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
