# In The Matter of Issuing an Administrative Order to Port of Longview pursuant to RCW 90.48.120 and WAC 173-201A

This is an Administrative Order requiring Port of Longview to comply with Chapter 90.48 RCW and the rules and regulations of the Department of Ecology (Ecology) by taking certain actions which are described below. RCW 90.48.120(2) authorizes Ecology to issue Administrative Orders requiring compliance whenever it determines that a person has violated or creates a substantial potential to violate any provision of Chapter 90.48 RCW.

The U.S. Army Corps of Engineers (Corps) issued a jurisdictional determination on June 5, 2018, concluding that Wetland C and D are not waters of the U.S. On August 2, 2023, Ecology received a request to impact 0.274 acres of non-federally regulated wetlands, which are waters of the state, to construct Port of Longview Industrial Rail Corridor Expansion (IRCE) Project in Cowlitz County. The project is located near 467 Fibre Way in Longview, Section 9, 10, and 11, Township 7N, Range 2W, and WRIA 25 Grays-Elochoman.

NOTE: Ecology has also issued a Section 401 Water Quality Certification No. 22603 for this project.

This Administrative Order authorizes 0.274 acres of Category 3 wetland impacts at the project location. Offsite Mitigation for this proposal will consist of 2.74 acres of wetland preservation and all other actions as proposed in the *Mitigation Plan,* prepared by Ecological Land Services, dated December 6, 2023. The mitigation will occur at Willow Grove Advance Wetland Mitigation Site on parcels WLI512002, WL1516001, 608640100, WL2201001, 60864, 60865, 608650100, and 608650200.

For purposes of this Order, the term "Project Proponent" shall mean Port of Longview and its agents, assigns, and contractors.

In view of the foregoing and in accordance with RCW 90.48.120(2):

IT IS ORDERED that the Project Proponent shall comply with the following:

#### A. General Conditions:

- 1. The Project Proponent shall construct and operate the project in a manner consistent with the project description contained in the JARPA received by Ecology on August 2, 2023, or as otherwise approved by Ecology.
- 2. For purposes of this Order, all submittals required by its conditions shall be sent to <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and a cc to <a href="mailto:Meghan.Tait@ecy.wa.gov">Meghan.Tait@ecy.wa.gov</a>. Any submittals shall reference Order No. 22614.
- 3. The Project Proponent shall provide access to the project site and mitigation site upon request by Ecology.
- 4. Copies of this Order shall be kept on the job site and readily available for reference by Ecology personnel, the construction superintendent, construction managers and forepersons, and state and local government inspectors.
- 5. Nothing in this Order waives Ecology's authority to issue additional orders if Ecology determines further actions are necessary to implement the water quality laws of the state. Further, Ecology retains continuing jurisdiction to make modifications hereto through supplemental order, if additional impacts due to project construction or operation are identified (e.g., violations of water quality standards, downstream erosion, etc.), or if additional conditions are necessary to further protect the public interest.
- 6. The Project Proponent shall ensure that all appropriate project engineers and contractors at the project site have read and understand relevant conditions of this Order and all permits, approvals, and documents referenced in this Order. The Project Proponent shall provide Ecology a signed statement (see Attachment A for an example) before construction begins at the project.
- 7. To transfer this Order to a new owner or operator the Project Proponent shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the Order's obligations, coverage, and liability and submit it to Ecology per condition A.2. Link to form: https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html;
  - b. Provide a copy of this Order to the new owner or operator; and
  - c. The transfer is not considered valid until the Project Proponent receives written notification from Ecology that the transfer has been approved.

8. The Project Proponent is responsible for obtaining all other permits, licenses, and certifications that may be required by federal, state, local or tribal authorities.

# **B.** Notification Requirements:

- 1. The Project Proponent shall provide written notification to Ecology in accordance with condition A.2 above for the following activities:
  - a. Immediately following a violation of the state water quality standards or when the project is out of compliance with any condition of this Order
  - b. At least ten (10) days prior to pre-construction meetings
  - c. At least ten (10) days prior to conducting work activities in wetlands
  - d. Within seven (7) days of completing work activities in wetlands.

# C. Wetland Mitigation Conditions:

- 1. The Project Proponent shall mitigate wetland impacts as described in the *Mitigation Plan* (hereafter called the "Mitigation Plan") prepared by Ecological Land Services, Inc., dated December 6, 2023, or as revised and approved by Ecology.
- 2. The Project Proponent shall notify and submit in writing to Ecology (see A.2) any proposed changes to the amount of wetland impacts or revision to the Mitigation Plan for review and approval before implementing the changes.
- 3. Prior to impacting wetlands, the Project Proponent shall submit to Ecology the following as proof of advance mitigation area withdrawal:
  - a. A ledger showing that the required amount of area has been deducted from the advance wetland mitigation site.
  - b. The ledger must include the Order number, Order issuance date, impact acreage, the amount of area required by the Order, and the date the area was deducted.
- 4. If the Project Proponent has not submitted the proof of advance mitigation withdrawal or completed Port of Longview Industrial Rail Corridor Expansion (IRCE) Project within 13 months of the date of this Order, the Project Proponent shall inform Ecology, in writing, of the status of:
  - a. Port of Longview Industrial Rail Corridor Expansion (IRCE) Project
  - b. When the advance mitigation ledger will be submitted

#### With the:

- a. Reason for delay
- b. Expected date of completion

The Project Proponent shall submit an updated written notification every 12 months thereafter until Port of Longview Industrial Rail Corridor Expansion (IRCE) Project is complete and the required ledger has been submitted.

5. Until the Project Proponent has received written notice from Ecology that the Mitigation Plan has been fully implemented, the Project Proponent's obligation under Condition C.1 to mitigate for wetland impacts is not met.

Failure to comply with this Order may result in the issuance of civil penalties or other actions, whether administrative or judicial, to enforce the terms of this Order.

# Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by RCW 43.21B and WAC 371-08. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in RCW 43.21B and WAC 371-08.
