Re: Coastal Zone Management Federal Consistency Decision for SR 104 Kingston Ferry Terminal Trestle Seismic Retrofit project (Corps No. NWS-2023-0292-DOT), Appletree Cove in Puget Sound, Kingston, Kitsap County, Washington

Dear Kevin Bartoy:

On June 14, 2024, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with WA State Ferries' determination that the proposed work is consistent with Washington's CZMP.

The proposed work entails seismically retrofit the Kingston Ferry Terminal by adding structural components to Slip 1 and removing and replacing sections of Slip 2 (also referred to as Slip 2 Approach Trestle). Additional work entails repairing a deteriorating bulkhead wall that provides support to the trestle where it connects to the shoreline.

Proposed Work/Slip 1

To reinforce Slip 1, three concrete caps will be added along the outside edge and connected to the existing Slip. Each concrete cap will require four 24" steel pipe piles. Steel framing utilizing two 30" steel pipe piles will be installed at the bridge seat of Slip 1.

Proposed Work/Slip 2 (approach trestle)

For Slip 2, twenty-three of the existing 18" octagonal concrete piles will be removed and replaced with twenty-six steel pipe piles that are 24" in diameter.

A fourth concrete cap will be installed and connected to the existing tie-in trestle that connects Slip 1 and Slip 2. This work will provide added structural stability to the terminal, in the event of

an earthquake. To repair the bulkhead wall, fourteen steel pipe piles, 30" in diameter, will be installed in front of the existing bulkhead. New sheet pile will be added in between the existing wall and the piles. The riprap located in front the bulkhead will be temporarily removed to allow access for the work and then put back in front of the repaired the structure.

This activity is located at 11320 Northeast on SR 104, Appletree Cove in Puget Sound, Kitsap County, Washington.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
