Re: Coastal Zone Management Federal Consistency Decision for Peak 410 Business Park

(Corps No. NWS-2023-0354), Wetlands, Bonney Lake, Pierce County, Washington

Dear Chris Leier:

On May 23, 2024, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Rainier RCL LLC's determination that the proposed work is consistent with Washington's CZMP.

The proposed work includes construction of the Peak 410 Business Park consisting of five one-story buildings, with warehouse and office space, and a combined footprint of 752,000 square feet (sf). With the associated paved parking area around the perimeter of the buildings and access roads, the combined impervious area is 33.25 acres (1,448,313 sf). To facilitate the proposal, 0.26 acre of direct wetland impact and 0.501 acre of indirect wetland impact are necessary. These impacts are to be mitigated for through 0.044 acres of onsite wetland creation, 1.086 acres of onsite wetland enhancement, 0.190 acres of offsite preservation (Fennel Creek and buffer), 0.799 acres of offsite upland preservation, and 0.522 acres of offsite wetland creation.

The project site is located in wetlands at 22719 SR 410 East, Bonney Lake, Pierce County, Washington, Section 2, Township 19N., Range 5E., within Water Resource Inventory Area (WRIA) 10, Puyallup-White.

Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
