Site Location	Hangman Creek Bank Stabilization and Habitat Enhancement located within Hangman Creek, Latah, Spokane County, Washington.

Spokane Conservation District submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Hangman Creek Bank Stabilization and Habitat Enhancement, Spokane County, Washington. The required processing dates are listed below:

- On 5/29/2024, the Spokane Conservation District submitted a pre-filing meeting request.
- On 7/3/2024, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 7/9/2024, Spokane Conservation District submitted additional information, and the Department of Ecology (Ecology) considered the request valid on this date.
- On 7/15/2024, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as 7/3/2025.

The project will stabilize approximately 2,000 linear feet of eroding stream-bank along Hangman Creek. Although the majority of the earthwork will occur along the right-bank of the creek, a section of approximately 165 feet will be addressed on the left-bank, near the upstream end of the project reach, to promote continuity throughout the entire reach. The stabilization effort will implement a bioengineering approach by excavating incised vertical streambanks and re-grading banks to 4:1 finished slopes, with placement of angular rock fill, Large Woody Debris and live willow cuttings to form a stable bank toe over approximately 1,315 linear feet of the reach. The project will restore the channel cross-section geometry through the reach and develop access to an active right-bank floodplain. The site restoration

will involve installation of native riparian vegetation along both banks throughout the entire project reach.

The project site is located at 17720 East Spring Valley Road, Hangman Creek, Spokane County, Washington, Section 30, Township 21 N., Range 45 E., within Water Resource Inventory Area (WRIA) 56 Hangman.

With this WQC Order, Ecology is granting with conditions Spokane Conservation District's request for a Section 401 Water Quality Certification for the Hangman Creek Bank Stabilization and Habitat Enhancement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 7/3/2024.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Spokane Conservation District must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Spokane Conservation District to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Spokane Conservation District from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Conditions:

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **23313** will remain valid for the duration of the associated Corps permit for the project.
 - Justification Certifications are required for any license or permit that authorizes an
 activity that may result in a discharge or fill material into waters. This WQC Order is
 not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
 able to specify how long the WQC Order will be in effect.

- Spokane Conservation District shall send a copy of the final Federal permit via e-mail to <u>fednotification@ecy.wa.gov</u> and cc to Federal Permit Manager prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, the Spokane Conservation District shall immediately inform Ecology.
 - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
 - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. Monitoring results shall be submitted monthly via e-mail to fednotification@ecy.wa.gov and cc to Taylor.Belisle@ecy.wa.gov.
 - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution and prevent exceedances of the water quality standards that protect aquatic life and beneficial uses.
 - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A
 WAC, WAC 173-201A-300 330, WAC 173-204-120, and WAC 173-225-010.
- 4. To transfer this WQC Order to a new owner or operator Spokane Conservation District shall:
 - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <u>fednotification@ecy.wa.gov</u> and cc to Federal Permit Manager. Link to form: https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html;
 - b. Provide a copy of this WQC Order to the new owner or operator; and
 - c. The transfer is not considered valid until the Spokane Conservation District receives written notification from Ecology that the transfer has been approved.
 - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.

- 5. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

• File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
