On September 11, 2024, the U.S. Environmental Protection Agency submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Marine Protection, Research, and Sanctuaries Act (MPRSA) General Permit for Ocean Disposal of Marine Mammal and Sea Turtle Carcasses in marine waters in Washington.

On behalf of the state of Washington, the Department of Ecology certifies that the work described in the Water Quality Certification Request and supplemental documents complies with applicable provisions of Sections 301, 302, 303, 306, and 307 of the Clean Water Act, as amended, and applicable state laws. This certification is subject to the enclosed Water Quality Certification Order (WQC Order).

The U.S. Environmental Protection Agency (EPA) submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Marine Protection, Research, and Sanctuaries Act (MPRSA) General Permit for Ocean Disposal of Marine Mammal and Sea Turtle Carcasses in marine waters in Washington. The required processing dates are listed below:

- On 5/10/2024, the EPA submitted a pre-filing meeting request.
- On 9/11/2024, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 9/26/2024, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as 3/11/2025.

The EPA is proposing to re-issue a general permit under the Marine Protection, Research and Sanctuaries Act (MPRSA) to authorize the transport and disposal of marine mammal and sea turtle carcasses in ocean waters, including the Puget Sound. In 2017, the EPA issued a general permit for the ocean disposal of marine mammal carcasses to streamline MPRSA authorization and reduce burdens associated with case-by-case permitting. Permit re-issuance is necessary because the most recent permit expired on January 4, 2024. The proposed general permit will be identical to the 2017 permit, except now would include authorization for disposal of marine mammal carcasses in Puget Sound.

With this WQC Order, Ecology is granting EPA's request for a Section 401 Water Quality Certification for the Marine Protection, Research, and Sanctuaries Act (MPRSA) General Permit for Ocean Disposal of Marine Mammal and Sea Turtle Carcasses project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 9/11/2024.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, the EPA must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize the EPA to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the EPA from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

This WQC Order is effective upon issuance of the EPA Marine Protection, Research, and Sanctuaries Act permit and will remain valid for seven years following the issuance of the permit. The EPA shall send a copy of the final permit via e-mail to <u>fednotification@ecy.wa.gov</u> and cc to Federal Permit Manager.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
