9400 SW Dolphin Point LLC (Sarah Holt) submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Kennedy-Goetz Bulkhead Replacement, King County, Washington. The required processing dates are listed below:

- On 9/24/2024, 9400 SW Dolphin Point LLC (Sarah Holt) submitted a pre-filing meeting request.
- On 1/29/2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 10/2/2024 the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under the Nationwide Permit (NWP) Program.
- Ecology's "Reasonable Period of Time" for this project has been established as 7/28/2025.
- On 2/11/2025, Ecology issued a public notice for the project.

This project proposes to replace an existing approximately 132-foot timber and concrete bulkhead with an angular rock bulkhead of the same length with inset rock steps.

Approximately 8 cubic yards of fallen rock on the beach will be restacked onto a section of existing rock bulkhead to the west. Work will occur at low tide from a barge and from the uplands where feasible. Suitable soil excavated for placement of the toe rock that contains native coarse sand and gravels will be placed on the beach as nourishment. After completion of bulkhead work, approximately 0.5 cubic yards of anthropogenic debris will be removed from the beach.

The project site is located at 9400 SW Dolphin Point Rd, in Puget Sound, King County, Washington, Section 8, Township 23 N., Range 3 E., within Water Resource Inventory Area (WRIA) 15 - Kitsap.

With this WQC Order, Ecology is granting with conditions 9400 SW Dolphin Point LLC (Sarah Holt)'s request for a Section 401 Water Quality Certification for the Kennedy-Goetz Bulkhead Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 1/29/2025.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize 9400 SW Dolphin Point LLC (Sarah Holt) to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves 9400 SW Dolphin Point LLC (Sarah Holt) from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

#### **Special Conditions:**

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **23502** will remain valid until 9/30/2026.
  - Justification Certifications are required for any license or permit that authorizes an
    activity that may result in a discharge or fill material into waters. This WQC Order is
    not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
    able to specify how long the WQC Order will be in effect.
  - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- 9400 SW Dolphin Point LLC (Sarah Holt) shall send a copy of the final Federal permit via e-mail to <u>fednotification@ecy.wa.gov</u> and cc to <u>Austin.Schmalz@ecy.wa.gov</u> prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, 9400 SW Dolphin Point LLC (Sarah Holt) shall immediately inform Ecology.

- Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
- Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator, 9400 SW Dolphin Point LLC (Sarah Holt) shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and cc to <a href="mailto:Austin.Schmalz@ecy.wa.gov">Austin.Schmalz@ecy.wa.gov</a>.   - b. Provide a copy of this WQC Order to the new owner or operator; and
  - c. The transfer is not considered valid until 9400 SW Dolphin Point LLC (Sarah Holt) receives written notification from Ecology that the transfer has been approved.
    - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
    - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. All activities within the wetted perimeter of the Puget Sound may be conducted between August 1 and September 30 of any year, and work will also be allowed from October 1 through December 31 and January 1 through February 15 of any year provided that a forage fish beach survey is conducted and surf smelt eggs are not found.
  - Justification This condition is reaffirming the project will take place during a time period that will not harm fish or other aquatic species.

5. Barge grounding will be limited to the extent practicable and restricted to the designated site in order to minimize potential direct or indirect impacts to eelgrass and forage fish spawning habitat.

- Justification This condition is necessary to protect shallow water habitat and prevent suspension of sediment. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
- Citation Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, 173-201A-300-330 WAC, and Chapter 173-204 WAC
- 6. Work below the ordinary high water mark will be conducted in the dry at low tide as described in the Joint Aquatics Resources Permit Application Form (JARPA).
  - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
  - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A
     WAC, WAC 173-201A-300-330, WAC 173-204-120, and WAC 173-225-010.
- 7. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
  - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. - File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
