On February 12, 2025, Northern Oyster Company Inc., submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Sheldon Northern Oyster Cultivation, Pacific County, Washington.

On behalf of the state of Washington, the Department of Ecology certifies with conditions that the work described in the Water Quality Certification Request and supplemental documents complies with applicable provisions of Sections 301, 302, 303, 306, and 307 of the Clean Water Act, as amended, and applicable state laws. # In The Matter of Granting a Water Quality Certification with Conditions to Northern Oyster Company Inc., pursuant to 33 U.S.C. 1341 (FWPCA § 401), RCW 90.48.120, RCW 90.48.260 and Chapter 173-201A WAC

Northern Oyster Company Inc. submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Sheldon Northern Oyster Cultivation, Pacific County, Washington. The required processing dates are listed below:

- On January 24, 2025, the Northern Oyster Company Inc. submitted a pre-filing meeting request.
- On February 12, 2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On February 21, 2025, Northern Oyster Company Inc. submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.
- On March 28, 2025, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as February 12, 2026.

This project proposes to commercially cultivate and harvest shellfish on up to 3.4 acres of tidelands (tax parcel 12112755186) in Willapa Bay. The applicant would cultivate oysters and clams within the 3.4-acre parcel utilizing both on- and off-bottom cultivation methods.

Clams seed would be broadcasted by hand into the intertidal area, with some portions of the 1.5-acre clam cultivation area netted. Netting would be secured by rebar stakes.

Oyster would be grown within a 1.5-acre area using off-bottom cultivation methods, which include oyster longlines, and floating or flip bags. These structures would be anchored to the substrate using rebar stakes and supported by PVC pipe. Rope for longlines may be strung and

set with spat on shell, or lines with bags and floats. Approximately 0.40 acre of the cultivation area would be incidental/secondary shellfish crop.

The applicant proposes to harvest manually by hand and mechanically using either dredge harvesting by boat or a bulb/greenhouse harvester. Access to the site is proposed by boat at high tide or adjacent uplands.

The project site is located in tidelands at Willapa Bay, Pacific County, Washington, Section 27, Township 12 N., Range 11 E., within Water Resource Inventory Area (WRIA) 24 Willapa.

With this WQC Order, Ecology is granting with conditions Northern Oyster Company Inc.'s request for a Section 401 Water Quality Certification for the Sheldon Northern Oyster Cultivation project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on February 12, 2025, and the following supporting documentation:

1. Water Quality Monitoring Plan, provided to Ecology on February 21, 2025.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Northern Oyster Company Inc. must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Northern Oyster Company Inc. to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Northern Oyster Company Inc. from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

#### **Special Conditions:**

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **23620** will remain valid until December 31, 2036.
  - Justification Certifications are required for any license or permit that authorizes an activity that may result in a discharge or fill material into waters. This WQC Order is not valid until the Federal agency issues a permit. Additionally, Ecology needs to be able to specify how long the WQC Order will be in effect.
  - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.

- Northern Oyster Company Inc. shall send a copy of the final Federal permit via e-mail to <u>fednotification@ecy.wa.gov</u> and <u>Lydia.Albright@ecy.wa.gov</u> prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, the Northern Oyster Company Inc. shall immediately inform Ecology.
  - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
  - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator Northern Oyster Company Inc. shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and cc Lydia.Albright@ecy.wa.gov. Link to form: <a href="https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html">https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html</a>;
  - b. Provide a copy of this WQC Order to the new owner or operator; and
  - c. The transfer is not considered valid until the Northern Oyster Company Inc. receives written notification from Ecology that the transfer has been approved.
    - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
    - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from

causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.

- Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to the Northern Oyster Company Inc. for the Sheldon Northern Oyster Cultivation project.

# Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
