# In The Matter of Granting a Water Quality Certification with Conditions to King County Local Services pursuant to 33 U.S.C. 1341 (FWPCA § 401), RCW 90.48.120, RCW 90.48.260 and Chapter 173-201A WAC

Site Location	NE 24th St Culvert Replacement located within Langlois Creek and the Tolt River 2 Wetland, near Carnation, King County, Washington.

King County Local Services submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the NE 24th St Culvert Replacement, King County, Washington. The required processing dates are listed below:

- On 12/12/2024, King County Local Services submitted a pre-filing meeting request.
- On 1/13/2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 9/23/2024, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under the Nationwide Permit (NWP) Program.
- Ecology's "Reasonable Period of Time" for this project has been established as 7/12/2025.
- On 1/27/2025, Ecology issued a public notice for the project.

The project proposes to replace an undersized, 60.5-foot-long, 42-inch-diameter corrugated metal pipe culvert with a new, 55-foot-long, 18-foot-wide, 5-foot-high, four-sided box culvert designed for fish passage. This involves excavating up to 967 cubic yards of material and discharging up to 507 cy of permanent fill below Ordinary High Water Mark along 181 linear feet of Langlois Creek. It also involves excavating up to 112 cy of wetland soil and streambed gravel and discharging up to 48 cy of fill within 520 square feet of the Tolt River 2 wetland. Replacement of the culvert will improve fish passage and allow continued residential access on NE 24th Street, the sole road access route to 63 residences east of the project site. A temporary bypass road and stream bypass will be installed and then removed after project completion. Disturbed areas beyond the traveled roadway surface and gravel shoulders will be planted and

restored. A bioswale will be installed and seeded on the southwest end of the project along the roadway to treat stormwater runoff.

The project site is located near 33609 NE 24th Street, Carnation, in Langlois Creek and the Tolt River 2 Wetland, King County, Washington, Section 27, Township 25 N., Range 07 E., within Water Resource Inventory Area (WRIA) 7, the Snohomish WRIA.

With this WQC Order, Ecology is granting with conditions King County Local Services' request for a Section 401 Water Quality Certification for the NE 24th St Culvert Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 1/13/2025, and the following supporting documentation:

- 1. E-mail letter and attachments to Ecology dated 4/9/2025, regarding the project's programmatic State Environmental Policy Act (SEPA) Determination of Nonsignificance Addendum, issued 11/21/2024.
- 2. Revised drawing set received 4/23/2025, dated April 2025.
- 3. E-mail letter to addressed to the Corps and Ecology dated 4/28/2025, regarding confirmation of impact areas and removal of additional fill placed by the City of Carnation.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, King County Local Services must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize King County Local Services to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves King County Local Services from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

#### **Special Conditions:**

 This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. 23537 will remain valid until December 31<sup>st</sup>, 2029.

- Justification Certifications are required for any license or permit that authorizes an
  activity that may result in a discharge or fill material into waters. This WQC Order is
  not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
  able to specify how long the WQC Order will be in effect.
- Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- King County Local Services shall send a copy of the final Federal permit via e-mail to <u>fednotification@ecy.wa.gov</u> and cc to <u>Austin.Schmalz@ecywa.gov</u> prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, King County Local Services shall immediately inform Ecology.
  - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
  - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator King County Local Services shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and cc to <a href="mailto:Austin.Schmalz@ecy.wa.gov">Austin.Schmalz@ecy.wa.gov</a>.   - b. Provide a copy of this WQC Order to the new owner or operator; and
  - c. The transfer is not considered valid until King County Local Services receives written notification from Ecology that the transfer has been approved.
    - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
    - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. All activities within the wetted perimeter of Langlois Creek may be conducted between July 15 and September 30.

• Justification - This condition is reaffirming the project will take place during a time period that will not harm fish or other aquatic species.

- Citation Chapter 77.55 RCW, Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A WAC, WAC 173-201A-300, WAC 173-201A-330, WAC 173-225-010, and Chapter 220-660 WAC.
- 5. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
  - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to the King County Local Services for the NE 24th St Culvert Replacement project.

## Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
