Site Location	Westport Marina Modernization - South Marina located within Grays Harbor, Westport, Grays Harbor County, Washington.

Port of Grays Harbor submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Westport Marina Modernization - South Marina project, Grays Harbor County, Washington. The required processing dates are listed below:

- On 6/27/2024, Port of Grays Harbor submitted a pre-filing meeting request.
- On 10/4/2024, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 10/14/2024, Port of Grays Harbor submitted additional information, and the Department of Ecology (Ecology) considered the Request valid on this date.
- On 2/11/2025, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as 10/4/2025.

This project proposes to demolish and remove five floats, then replace four of these floats in a reconfigured footprint. This activity involves removal of all four floats in the South Marina (Floats 15, 17, 19, and 21), one float in the Mid Marina (Float 11) and all the associated structures (piles, gangways, and approach piers). Floats 11, 15, 17, and 21 would be replaced with four new floats, piles, gangways, approach piers, and other components. Float 19 would not be replaced. The new structures would be repositioned, re-sized, and reconfigured to reduce the number of slips but increase the size of the vessel that each slip can accommodate.

The project site is located at Westport Marina (Port of Grays Harbor) - 326 Lamb Street, Westport, Grays Harbor County, Washington, Section 1, Township 16 N., Range 11 W., within Water Resource Inventory Area (WRIA) 22 Lower Chehalis.

With this WQC Order, Ecology is granting with conditions Port of Grays Harbor's request for a Section 401 Water Quality Certification for the Westport Marina Modernization - South Marina project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 10/4/2024, and the following supporting documentation:

- 1. State Environmental Policy Act, Mitigated Determination of Nonsignificance 8/29/2024.
- 2. A Biological Evaluation submitted by email to Ecology on 10/14/2024.
- 3. Visual Water Quality Monitoring Plan submitted by email to Ecology on 3/14/2025.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Port of Grays Harbor must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Port of Grays Harbor to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Port of Grays Harbor from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Conditions:

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **23638** will remain valid until 2/15/2036.
 - Justification Certifications are required for any license or permit that authorizes an
 activity that may result in a discharge or fill material into waters. This WQC Order is
 not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
 able to specify how long the WQC Order will be in effect.
 - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- Port of Grays Harbor shall send a copy of the final Federal permit via e-mail to
 <u>fednotification@ecy.wa.gov</u> and cc to <u>Erin.Everton@ecy.wa.gov</u> prior to the starting of any
 work authorized by this WQC Order. If the Federal Agency determines the proposed project
 does not require a Federal permit, Port of Grays Harbor shall immediately inform Ecology.
 - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.

- Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator Port of Grays Harbor shall:
 - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at fednotification@ecy.wa.gov and cc to Erin.Everton@ecy.wa.gov. Link to form: https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html;
 - b. Provide a copy of this WQC Order to the new owner or operator; and
 - c. The transfer is not considered valid until Port of Grays Harbor receives written notification from Ecology that the transfer has been approved.
 - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
 - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
 - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. - 5. The Port of Grays Harbor shall conduct water quality monitoring as described in the approved Visual Water Quality Monitoring Plan.
 - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution and prevent exceedances of the water quality standards that protect aquatic life and beneficial uses.
 - Citation RCW 90.48, RCW 90.48.030, Chapter 173-201A WAC, 173-201A-300-330 and WAC 173-225-010.
- 6. Barges shall not be allowed to ground-out during in-water construction.
 - Justification This condition is necessary to protect shallow water habitat and prevent suspension of sediment. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
 - Citation Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, 173-201A-300-330 WAC, and Chapter 173-204 WAC
- 7. Pile removal, handling, and disposal shall follow the EPA Region 10 Best Management Practices for Piling Removal and Placement in Washington State, dated February 18, 2016.
 - Justification- Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
 - Citations- Chapter 77.55 RCW, Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A WAC, WAC 173-201A-300, WAC 173-201A-330, WAC 173-225-010, and Chapter 220-660 WAC.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to Port of Grays Harbor for the Westport Marina Modernization - South Marina project.

Your right to appeal

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
