Re: Coastal Zone Management Federal Consistency Decision for Tributary to Gosnell Creek Restoration Project (Corps No. 202400023), Mason County, Washington

Dear Halli Baumann:

On 4/28/2025, the Department of Ecology (Ecology) received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project. Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Northwest Pipeline, LLC's determination that the proposed work is consistent with Washington's CZMP.

This project proposes to remediate an exposed area of the Shelton Lateral Pipeline that will involve a channel realignment of the stream with grading activity to lower and widen the stream floodplain. The south bank of the stream will be graded on top of the exposed pipeline. It is the intent of the project design to achieve stream enhancement and habitat improvements. The project site is located near Shelton, tributary to Gosnell Cr., Mason County, Washington, Section NE 12, Township 19 N., Range 4 W., within Water Resource Inventory Area (WRIA) 14 Kennedy-Goldsborough.

# Your right to appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this decision:

- File your notice of appeal and a copy of this decision with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this decision on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
