# In The Matter of Granting a Water Quality Certification with Conditions to Newport Yacht Club pursuant to 33 U.S.C. 1341 (FWPCA § 401), RCW 90.48.120, RCW 90.48.260 and Chapter 173-201A WAC

Site Location	Newport Yacht Club Bulkhead Replacement project located within Lake Washington, Bellevue, King County, Washington.

Newport Yacht Club submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Newport Yacht Club Bulkhead Replacement project, King County, Washington. The required processing dates are listed below:

- On 3/26/2025, the Newport Yacht Club submitted a pre-filing meeting request.
- On 6/16/2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 6/18/2025, the U.S. Army Corps of Engineers (Corps) confirmed with Ecology that they are continuing to process the project under Nationwide Permit Program.
- On 6/30/2025, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as 12/13/2025.

The project proposes to replace a total of 248 linear feet (LF) of existing creosote-treated timber bulkhead with approximately 260 LF of a steel sheet pile bulkhead, which would be installed landward of the existing bulkhead location above ordinary high water. The difference in length is due to the placement of the new bulkhead landward of the existing bulkhead and an adjustment in the alignment to correct angles/connections for constructability. The project also proposes to install approximately 117 LF of sheet pile bulkhead landward of existing beach riprap between timber bulkhead segments. The area behind the existing bulkhead would be excavated, timber would be removed, and sheet piles would then be installed via vibratory hammer. Work would occur in the dry when the lake is at a water level below the existing bulkhead.

The project site is located at 81 Skagit Key, Bellevue, Lake Washington, King County, Washington, Section 17, Township 24 N., Range 05 E., within Water Resource Inventory Area (WRIA) 08 Cedar-Sammamish.

With this WQC Order, Ecology is granting with conditions Newport Yacht Club's request for a Section 401 Water Quality Certification for the Newport Yacht Club Bulkhead Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 6/16/2025 and the E-mail letter to Ecology dated 6/26/2025 regarding the removal of the boat lift- and kayak launch-related elements from the proposal.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Newport Yacht Club must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Newport Yacht Club to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Newport Yacht Club from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

#### **Special Conditions:**

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **23223** will remain valid until February 28<sup>th</sup>, 2027.
  - Justification Certifications are required for any license or permit that authorizes an
    activity that may result in a discharge or fill material into waters. This WQC Order is
    not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
    able to specify how long the WQC Order will be in effect.
  - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- Newport Yacht Club shall send a copy of the final Federal permit via e-mail to fednotification@ecy.wa.gov and cc to <u>Austin.Schmalz@ecy.wa.gov</u> prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, Newport Yacht Club shall immediately inform Ecology.

- Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
- Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator Newport Yacht Club shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and cc to <a href="mailto:Austin.Schmalz@ecy.wa.gov">Austin.Schmalz@ecy.wa.gov</a>.   - b. Provide a copy of this WQC Order to the new owner or operator; and
  - c. The transfer is not considered valid until Newport Yacht Club receives written notification from Ecology that the transfer has been approved.
    - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
    - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. All activities within the wetted perimeter of the Puget Sound may be conducted between July 16 and July 31 and also between November 16 and December 31 of any year.
  - Justification This condition is reaffirming the project will take place during a time period that will not harm fish or other aquatic species.
  - Citation Chapter 77.55 RCW, Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A WAC, WAC 173-201A-300, WAC 173-201A-330, WAC 173-225-010, and Chapter 220-660 WAC.
- 5. Newport Yacht Club shall conduct visual water quality monitoring as described in the Joint Aquatics Resources Permit Application Form (JARPA) received by Ecology on 6/16/2025.

- 6. Turbidity curtains shall be properly deployed and maintained in order to minimize turbidity and re-suspension of sediment.
  - Justification This condition ensures containment and limits movement of sediment that could cause water quality exceedances. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
  - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A
     WAC, WAC 173-201A-300 330, WAC 173-204-120, and WAC 173-225-010.
- 7. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
  - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. - File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
