On behalf of the state of Washington, the Department of Ecology certifies with conditions that the work described in the Water Quality Certification Request and supplemental documents complies with applicable provisions of Sections 301, 302, 303, 306, and 307 of the Clean Water Act, as amended, and applicable state laws. Site Location	Demmert Bulkhead Replacement located within Saratoga Passage, Camano Island, Island County, Washington.

Steven Demmert submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Demmert Bulkhead Replacement, Island County, Washington. The required processing dates are listed below:

- On 1/14/2025, Steven Demmert submitted a pre-filing meeting request.
- On 3/27/2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- Ecology's "Reasonable Period of Time" for this project has been established as 3/27/2026.
- On 4/18/2025, Ecology issued a public notice for the project.

This project proposes to remove an existing 80-foot rockery revetment and install a replacement concrete bulkhead 1 foot waterward of the existing revetment along 80 linear feet. The existing riprap would be removed and stockpiled within a 25- to 30-foot work zone in the upper intertidal to be used as backfill landward of the replacement bulkhead. A small excavator would be used to dismantle the rockery armoring and to remove rubble from a previously existing concrete bulkhead remaining onsite. Excavation would occur to construct the new footing of the concrete bulkhead. The new bulkhead would be constructed using concrete poured in place into sealed forms. Concrete would be fully cured before allowing contact with water. Once the concrete bulkhead is installed, riprap boulders would be placed back against the embankment landward of the installed bulkhead. A concrete bulkhead previously existed onsite 7.5 feet waterward of the proposed bulkhead face; however, the structure failed in 2021 following a previous storm and temporary rockery was added to prevent further erosion onsite. While the replacement concrete bulkhead would be installed 1 foot waterward of the existing rock, it would be installed 7 feet landward of the previous concrete bulkhead face. Remains of the failed bulkhead would be used to backfill behind the

new concrete wall or removed from the site. Construction access would be by land at an access point 100 feet north of the project site. No machinery would be stored on the beach. Access to pour the cement and install the concrete bulkhead would be from the uplands. Once completed, an additional beach substrate would be placed for beach nourishment as required by Washington Dept of Fish and Wildlife. The purpose of the project is erosion protection.

The project site is located at 235 North Sunset Drive, Saratoga Passage, Island County, Washington, Section 34, Township 32 N., Range 2 E., within Water Resource Inventory Area (WRIA) 6 - Island.

With this WQC Order, Ecology is granting with conditions Steven Demmert's request for a Section 401 Water Quality Certification for the Demmert Bulkhead Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 3/27/2025, and the following supporting documentation:

1. E-mail to Ecology dated 7/25/2025 regarding the project's Biological Site Assessment and construction methods.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Steven Demmert must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Steven Demmert to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Steven Demmert from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Conditions:

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **24064** will remain valid until February 15, 2028.
 - Justification Certifications are required for any license or permit that authorizes an
 activity that may result in a discharge or fill material into waters. This WQC Order is
 not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
 able to specify how long the WQC Order will be in effect.

- Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- Steven Demmert shall send a copy of the final Federal permit via e-mail to
 <u>fednotification@ecy.wa.gov</u> and cc to <u>Austin.Schmalz@ecy.wa.gov</u> prior to the starting of
 any work authorized by this WQC Order. If the Federal Agency determines the proposed
 project does not require a Federal permit, the Steven Demmert shall immediately inform
 <u>Ecology</u>.
 - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
 - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator Steven Demmert shall:
 - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at fednotification@ecy.wa.gov and cc to Austin.Schmalz@ecy.wa.gov. Link to form: https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html;
 - b. Provide a copy of this WQC Order to the new owner or operator; and
 - c. The transfer is not considered valid until the Steven Demmert receives written notification from Ecology that the transfer has been approved.
 - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
 - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. The following in-water work window applies to the project: all activities within the wetted perimeter of the Saratoga Passage may be conducted between August 1 and February 15 of any year provided that a forage fish beach survey is conducted, surf smelt eggs are not found, and work begins within 72 hours of the survey.

- Justification This condition is reaffirming the project will take place during a time period that will not harm fish or other aquatic species.
- Citation Chapter 77.55 RCW, Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A WAC, WAC 173-201A-300, WAC 173-201A-330, WAC 173-225-010, and Chapter 220-660 WAC.
- 5. Work below the ordinary high water mark, including staging of materials, shall be conducted in the dry at low tide.
 - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
 - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A
 WAC, WAC 173-201A-300-330, WAC 173-204-120, and WAC 173-225-010.
- 6. All concrete shall be completely cured prior to coming into contact with water.
 - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
 - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A
 WAC, WAC 173-201A-300 330, WAC 173-204-120, and WAC 173-225-010.
- 7. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
 - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm. Ecology must protect waters of the state from all discharges

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to the Steven Demmert for the Demmert Bulkhead Replacement project.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
