# In The Matter of Granting a Water Quality Certification with Conditions to Alex Perlman and Karla Oman pursuant to 33 U.S.C. 1341 (FWPCA § 401), RCW 90.48.120, RCW 90.48.260 and Chapter 173-201A WAC

Alex Perlman and Karla Oman submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Perlman-Oman Bulkhead Replacement, Mason County, Washington. The following required processing dates are listed below:

- On 5/1/2025, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under the Nationwide Permit (NWP) Program.
- On 5/27/2025, Alex Perlman and Karla Oman submitted a pre-filing meeting request.
- On 7/25/2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On 8/14/2025, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as 1/21/2026.

This project proposes to permanently discharge up to 10 cubic yards of gravel and remove an existing 60-linear foot derelict concrete bulkhead, additional derelict armoring, and access stairs waterward of the High Tide Line and Mean High Water line of elevation in Hood Canal. A new 70-foot-long bulkhead, composed of soldier piles and pre-cast concrete blocks, would be installed two feet landward of the existing bulkhead. Access to the site will be via barge.

The project site is located at 13753 NE North Shore Road, Hood Canal, Mason County, Washington, Section 22, Township 27 N., Range 03 E., within Water Resource Inventory Area (WRIA) 15 Kitsap.

With this WQC Order, Ecology is granting with conditions Alex Perlman's and Karla Oman's request for a Section 401 Water Quality Certification for the Perlman-Oman Bulkhead

Replacement project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on 7/25/2025, and the following supporting documentation:

1. E-mail to Ecology dated 8/13/2025, regarding the project's visual water quality monitoring.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Alex Perlman and Karla Oman must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Alex Perlman and Karla Oman to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Alex Perlman and Karla Oman from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

#### **Special Conditions:**

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **24151** will remain valid until January 15, 2027.
  - Justification Certifications are required for any license or permit that authorizes an activity that may result in a discharge or fill material into waters. This WQC Order is not valid until the Federal agency issues a permit. Additionally, Ecology needs to be able to specify how long the WQC Order will be in effect.
  - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- Alex Perlman and Karla Oman shall send a copy of the final Federal permit via e-mail to fednotification@ecy.wa.gov and cc to Erin.Everton@ecy.wa.gov prior to the starting of any work authorized by this WQC Order. If the Federal Agency determines the proposed project does not require a Federal permit, Alex Perlman and Karla Oman shall immediately inform Ecology.
  - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
  - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.

- 3. To transfer this WQC Order to a new owner or operator Alex Perlman and Karla Oman shall:
  - a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at <a href="mailto:fednotification@ecy.wa.gov">fednotification@ecy.wa.gov</a> and cc to Federal Permit Manager. Link to form: <a href="https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html">https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html</a>;
  - b. Provide a copy of this WQC Order to the new owner or operator; and
  - c. The transfer is not considered valid until Alex Perlman and Karla Oman receives written notification from Ecology that the transfer has been approved.
    - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
    - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
  - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. - 5. Barges shall not be allowed to ground-out during in-water construction.
  - Justification This condition is necessary to protect shallow water habitat and prevent suspension of sediment. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
  - Citation Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, 173-201A-300-330 WAC, and Chapter 173-204 WAC.
- 6. Barges shall be kept free of material that could be blown into the water.
  - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
  - Citation -Chapter 70A-200 RCW, RCW 79.02-300, Chapter 90.48 RCW, and WAC 173-225-010.
- 7. Work within waters of the state shall be conducted in the dry to the extent practicable.
  - Justification Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.
  - Citation Chapter 90.48 RCW, RCW 90.48.030, RCW 90.48.080, Chapter 173-201A WAC, WAC 173-201A-300-330, WAC 173-204-120, and WAC 173-225-010.
- 8. The following in-water work windows apply to the project:
  - a. All activities below the Ordinary High Water Mark of Hood Canal may be conducted between July 15 December 31 and January 1 January 15 of any year.
    - Justification This condition is reaffirming the project will take place during a time period that will not harm fish or other aquatic species.

#### Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology, in paper form, by mail, or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
