Walsh Trucking submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for Walsh Trucking, Lewis County, Washington. The required processing dates are listed below:

- On June 17, 2025, the Walsh Trucking submitted a pre-filing meeting request.
- On June 17, 2025, the U.S. Army Corps of Engineers (Corps) sent an email notification to Ecology that they are reviewing the project for authorization under the Nationwide Permit (NWP) Program.
- On July 18, 2025, Ecology received a request for Clean Water Section 401 Water Quality Certification.
- On July 29, 2025, Ecology issued a public notice for the project.
- Ecology's "Reasonable Period of Time" for this project has been established as November 15, 2025.

This project proposes to expand an existing trucking facility adjacent to a highway exit which will have 0.33-acre of direct wetland impact and 0.585-acre indirect wetland impacts to category III and IV depressional wetlands. Mitigation for direct and indirect impacts will consist of purchasing 0.619-credit from the Chehalis Basin Wetland Mitigation Bank (CBWMB).

The project site is located within wetlands, Lewis County, Washington, Section 25, Township 13 N., Range 2 W., within Water Resource Inventory Area (WRIA) 23 Upper Chehalis.

With this WQC Order, Ecology is granting with conditions Walsh Trucking's request for a Section 401 Water Quality Certification for the Walsh Trucking project, provided that the activity is

conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on July 18, 2025, and the following supporting documentation:

1. The Bank Use Plan dated October 10, 2025, received October 16, 2025.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Walsh Trucking must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Walsh Trucking to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC), or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves Walsh Trucking from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Special Conditions:

- 1. This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a Department of the Army (DA) permit for this project. WQC Order No. **24234** will remain valid until March 31, 2027.
 - Justification Certifications are required for any license or permit that authorizes an
 activity that may result in a discharge or fill material into waters. This WQC Order is
 not valid until the Federal agency issues a permit. Additionally, Ecology needs to be
 able to specify how long the WQC Order will be in effect.
 - Citation Chapter 90.48 RCW, Chapter 173-201A WAC, and WAC 173-225-010.
- Walsh Trucking shall send a copy of the final Federal permit via e-mail to
 <u>fednotification@ecy.wa.gov</u> and cc to <u>Lydia.Albright@ecy.wa.gov</u> prior to the starting of
 any work authorized by this WQC Order. If the Federal Agency determines the proposed
 project does not require a Federal permit, the Walsh Trucking shall immediately inform
 <u>Ecology</u>.
 - Justification This condition is needed to ensure that the federal permit has been issued and all the conditions of the WQC Order have been included into the federal permit.
 - Citation 40 CFR 121.10, 40 CFR 121.11, and Chapter 90.48 RCW.
- 3. To transfer this WQC Order to a new owner or operator Walsh Trucking shall:

- a. Complete a Request for Transfer of Order with a specific transfer date of the WQC Order's obligations, coverage, and liability and submit it to Ecology at fednotification@ecy.wa.gov and cc to Lydia.Albright@ecy.wa.gov. Link to form: https://apps.ecology.wa.gov/publications/SummaryPages/ECY070695.html;
- b. Provide a copy of this WQC Order to the new owner or operator; and
- c. The transfer is not considered valid until the Walsh Trucking receives written notification from Ecology that the transfer has been approved.
 - Justification Ecology has independent state authority to ensure protection of state water quality. Ecology needs to ensure that anyone conducting work at the project, including any new owners or operators, are aware of and understand the required conditions of this WQC Order to ensure compliance with the water quality standards and other applicable state laws.
 - Citation 40 CFR 121.5, Chapter 90.48 RCW, RCW 90.48.030, Chapter 173-201A WAC, and WAC 173-225-010.
- 4. Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for spills to water only. This condition is necessary to prevent oil and other hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm.
 - Justification This condition is necessary to prevent oil and hazardous materials spills from causing environmental damage and to ensure compliance with water quality requirements. The sooner a spill is reported, the quicker it can be addressed, resulting in less harm. Ecology must protect waters of the state from all discharges and potential discharges of pollution that can affect water quality to protect aquatic life and beneficial uses.

- 5. The Walsh Trucking shall mitigate wetland impacts as described in Bank Use Plan, dated Oct 10, 2025, prepared by Ecological Land Services (hereafter called the "Mitigation Plan") as identified above or as required by this Order.
 - Justification Alteration of water quality necessitates the use of mitigation as a
 method of controlling pollution. When adequate mitigation is provided, the impacts
 are not considered significant enough to water quality, at least in the long-term. The
 water quality standards, along with mitigation, protect wetlands as well as
 permitting some level of degradation where unavoidable or necessary.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.
- 6. The Walsh Trucking shall submit any proposed changes to the Mitigation Plan in writing to Ecology via e-mail to fednotification@ecy.wa.gov and cc to Lydia.Albright@ecy.wa.gov for review, as described in the Mitigation Plan before implementing the changes.
 - Justification When adequate mitigation is provided, the water quality impacts are
 offset and not considered significant, at least in the long-term. Changes to impacts
 or mitigation must be considered when evaluating mitigation adequacy.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.
- 7. Prior to impacting wetlands, the Walsh Trucking shall submit to Ecology documentation from the bank sponsor verifying the purchase of 0.619 wetland mitigation bank credits (credits) from the Chehalis Basin Wetland Mitigation Bank. This documentation must include the Ecology Order Number, Order issuance date, impact acreage, the amount of credits required by the Order, and date of credit purchase.
 - Justification This condition is necessary to ensure the compensatory mitigation was actually provided by the bank.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.

- 8. Unless otherwise authorized by this WQC Order, the Walsh Trucking shall complete the purchase of credits before impacting wetlands. Otherwise, Ecology may require the Walsh Trucking to provide additional compensation to account for additional temporal loss of wetland functions.
 - Justification Mitigation that is not emplaced concurrent with impacts will result in degradation of existing beneficial uses of the wetlands affected by the proposed action through temporal loss of functions.
 - Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300 and WAC 173-225-010.
- 9. If the Walsh Trucking has not purchased credits within 13 months of the date of this Order, the Walsh Trucking shall inform Ecology, in writing, of the status of:
 - a. Walsh Trucking project.
 - b. When bank credits will be purchased.

With the:

- c. Reason for the delay.
- d. Expected date of completion.

The Walsh Trucking shall submit an updated written notification every 12 months thereafter until Walsh Trucking project is complete and the required credits are purchased.

- Justification Mitigation that is not emplaced concurrent with impacts will result in degradation of existing beneficial uses of the wetlands affected by the proposed action through temporal loss of functions.
- Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC 173-225-010.
- 10. The Walsh Trucking's obligation to compensate for wetland impacts under Condition 5 is not met until the Walsh Trucking has received written notice from Ecology that the obligation is met.

- Justification If the mitigation site is not meeting all compensatory mitigation conditions then the water quality impacts will not be offset by the mitigation.
- Citation 33 CFR 332, 40 CFR 131.12, 40 CFR 230, subpart J, RCW 47.85.040, Chapter 90.48 RCW, Chapter 90.54 RCW, Chapter 90.74 RCW, Chapter 173-201A WAC, WAC 173-201A-260 (3)(i-ii), WAC 173-201A-300, and WAC173-225-010.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted with conditions to the Walsh Trucking for the Walsh Trucking project.

Your right to appeal

You have a right to appeal this Order to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do all of the following within 30 days of the date of receipt of this Order:

- File your notice of appeal and a copy of this Order with the PCHB (see filing information below). "Filing" means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your notice of appeal and this Order on the Department of Ecology by mail, in person, or by email (see addresses below).

You must also comply with other applicable requirements in Chapters 43.21B RCW and 371-08 WAC.
