RE: Coastal Zone Consistency for Activity Undertaken by a Federal Agency

South Jetty Breach Fill Maintenance

City of Westport, Grays Harbor County, Washington

Dear Laura Boerner:

On July 11, 2019, the U.S. Army Corps of Engineers (Corps) submitted a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP). The federal activity entails placing sand on a spit that connects the South Jetty with the land mass to the south and is at risk of being breached by wave/tidal action. The work would occur over a 5 year period (2019-2024). Sand will be placed upland above elevation +9 feet mean lower low water at two different locations on the spit: up to 30,000 cubic yards at a 3.1 acre site referred to as Site A, Half Moon Bay and up to 60,000 cubic yards at a 5.8 acre site referred to as Site B, South Beach. The material will be sourced from adjacent dredging activities in the area or brought in by truck from an upland quarry. All material will be tested to ensure it is free of contamination. The project is located in the Westhaven State Park in the City of Westport, Grays Harbor County, Washington.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Department of Ecology (Ecology) concurs with Corps' determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
