Dear Bridgette Glass:

On June 2, 2020, Washington Department of Fish and Wildlife (WDFW) submitted a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP).

This determination is for construction of a parking lot and entrance ramp from Bayview Edison Road to the Samish River Wildlife Unit.

The project is located near 6496 Bayview Edison Road, and the mitigation site is near 12561 Samish Island Road, Edison, Washington, in Skagit County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with WDFW's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
