On November 18, 2020, The Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the maintenance to an existing 363 square foot pier including the replacement of the caps, stringers, and decking. These improvements would be located 4293 E Lake Sammamish Shore Lane SE, Sammamish, Washington in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Christopher and Kristy Barry's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.
