Dear Jonny Limantzakis:

On November 6, 2020, The Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the demolition of an existing dock and piles and the construction of an entry, walkway with ELL at the end, and a finger. The project also includes driving 26 new 8 inch steel support piles. These improvements would be located at 15514 Beach Drive NE, Lake Forest Park in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Jonny Limantzakis' determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

• File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
